1. SINCE THE ARREST OF WERNER PAUL REICH BOHNIG BY 25 APRIL 1966, FOLL INFO OBTAINED FROM INTERROGATIONS THROUGH AND
 - A. REICH ENTERED PERU FROM RIO DE JANEIRO BY AIR 26 APRIL 1961 WITH FRAUDULENT WEST GERMAN PASSPORT K-111-56 MADE OUT IN ALIAS. PASSPORT ISSUED IN KONSTANZ, GERMANY UNKNOWN DATE. REICH'S TRUE IDENTITY REVEALED AS PIERRE ROBERT ROESCH, GERMAN CITIZEN, BORN 1 MARCH 1921 IN PARIS. CARRIES BIRTH CERTIFICATE NO C 046077 ISSUED BY SEINE PREFECTURE, 12TH ARONDISSEMENT. FATHER'S NAME ROBERT ROESCH WHO RESIDING 2 BIS RUE ETIENNE, MAREY, PARIS. MOTHER'S NAME AIMEE OLYMPE DESCLEE. FIRST WIFE OF SUBJECT IDENTIFIED AS FRENCH CIT. HELENE JEANNINE DELABIE WHO ALLEGEDLY COMMITTED SUICIDE ON UNSPECIFIED DATE AFTER KILLING HER THREE

CHILDREN. SUBJECT'S SECOND WIFE IDENTIFIED AS FRIEDERIKE SCHLAPP WHO CURRENTLY LIVING WITH THEIR TEN YEAR OLD DAUGHTER PATRICIA IN BRIXLEGG TIROL, AUSTRIA. ASSUME THEY ARE DIVORCED SINCE SUBJ REFERS TO HER AS HIS EX-WIFE.

B. SUBJ CLAIMS TO HAVE ENLISTED IN GERMAN ARMY OF OCCUPATION AS FRENCH VOLUNTEER IN WW II. SERVED AS LT IN S.S. ^mCOMANDO UNIT. WHEN WAR ENDED HE WAS IMPRISONED, TRIED AND SERVED OUT THREE YEARS OF 7 YEAR SENTENCE AT HARD LABOR; PAROLED AFTER 3 YRS BECAUSE OF GOOD BEHAVIOUR FOLLOWING WHICH SET UP PUBLICITY AGENCY IN PARIS. SUBSEQUENTLY GOT INTO POLITICAL HASSLE WITH ROBERT BURON, MEMBER FRENCH CABINET WHICH RESULTED IN HIS FINANCIAL RUIN. MADE ILLEGAL BORDER CROSSING INTO ITALY TO ESCAPE JUDICIAL POLICE AND FROM THERE ENTERED GERMANY BY WAY OF AUSTRIA. ATTEMPTED OBTAIN LEGALLY W. GERM PASSPORT FROM NUREMBURG POLICE THROUGH ROBERT SCHURMANN OF WETZLAR, HESSE, EX-CAPT IN S.S. WITH WHOM SUBJ HAD SERVED DURING WW II. VIEW HIS ILLEGAL ENTRY INTO GERMANY AND FACT HE WAS INVOLVED IN LITIGATION WITH FRENCH CABINET MINISTER SUBJ WAS REFUSED LEGAL PASSPORT THOUGH HE COULD JUSTIFY CLAIM TO GERMAN CIT. AFTER FAILING

OBTAIN FALSE PASSPORT IN NUREMBURG, SUBJ WAS DIRECTED GO KONSTANZ NEAR SWISS BORDER WHERE HE PURCHASED ONE FOR 150 MARKS IN NAME OF WERNER PAUL REICH. USED IT TO TRAVEL CHILE VIA AUSTRIA AND NAPLES, ITALY WHERE HE BOARDED SHIP "MARCO POLO." AFTER TAKING OUT RESIDENCY PAPERS IN CHILE WENT TO ASUNCION, PARAGUAY THEN BRAZIL FROM WHERE HE EVENTUALLY CAME TO LIMA.

C. HAS LIVED UNDER PSEUDOS JUAN CAILLOT AND SIEGFRIED SCHNEIDER SINCE ARRIVING LIMA. SINCE SUBJ REFUSED EXTENSION HIS STAY IN PERU ON THIRD APPEAL TO PERUVIAN FOREIGN MINISTRY HIS CONTINUED PRESENCE IN PERU CONSIDERED ILLEGAL SINCE 26 JAN 1962. SUBJ AVOIDED ARREST BY CHANGING JOBS AND ADDRESSED AND THRU USE ABOVE ALIASES. AFTER ESTABLISHING CONTACT WITH FEDERICO AKA FRITZ SCHWEND^P EARLY 1965 WAS INVITED BECOME LATTER'S HOUSE GUEST. SUBJ HARBORED IN SCHWEND HOUSE ON OUTSKIRTS OF LIMA UNTIL JULY 65 WHEN ON OWN VOLITION LEFT TO ESCAPE SCHWEND PLOTTING AND ILLICIT SCHEMES. ACCUSATIONS BROUGHT AGAINST SCHWEND BY SUBJ DURING DUBRIDE INTERROGATIONS WILL BE MADE SUBJECT FOLLOW UP DISPATCH ACCOMPANIED BY COPIES ROESCH'S ORIGINAL CONFESSION AND STATEMENTS MADE

D. LIKE TIDOW SUBJ REITERATES CLAIM IN HIS TESTIMONY THAT JOSEPH J. PALISI, FORMER ODWIFER CONNECTED WITH AIFLD, SERVING AS CHIEF KUBARK REP LATIN AMERICA. MAKES CLAIM THAT PALISI SENT HIM (SUBJECT) SMALL SUMS OF MONEY PERIODICALLY TO HELP HIM MAKE ENDS MEET. (BECAUSE OF SUBJECT'S TESTIMONY LINKING HIMSELF AND SCHWEND TO PALISI, STATION CONVINCED THAT THE JOHN PALACE CITED [] 6759 AND [] 8841 IDENTICAL WITH PALISI). ^(IN 97215)
