1. REQUEST HQS APPROVAL FOLLOWING PROPOSAL.
2. () FEELS RELATION WITH () AND THROUGH HIM PODAM, HAS MATURED SUFFICIENTLY THAT () CAN BEGIN MAKING CONCRETE PROPOSAL FOR COLLABORATION TO THEM. BECAUSE PODAM IS OUTSPOKENLY AND AGGRESSIVELY ANTI-COMMUNIST, () FEELS THE GREATEST PROFIT TO KUBARK WOULD ACCRUE WERE FIRST PROPOSITION TO BE CHANNLED ALONG LINES USING PODAM'S ASSETS AGAINST JCP IN MOST TELLING FASHION. ULTIMATE PROPOSAL WOULD BE FOR () TO FURNISH TWO OR AT MOST THREE EXPERTS, FOR PODAM TO FURNISH AN EQUAL OR SLIGHTLY LARGER NUMBER. UNWITTING OF THIS PROPOSAL.

3. () FEELS PROPOSAL WILL BE MORE THOROUGHLY AND INTELLIGENTLY IMPLEMENTED IF OUR SIDE REPRESENTS SELF AS KUBARK. HOWEVER THIS NOT VITAL TO SCHEME, () WHEN POINT RAISED, REPRESENTED SELF AS ODIBEX, BUT ASSUMES () KNOWS TRUE EMPLOYER, ALTHOUGH HE HAS NEVER RAISED.

4. ARRANGEMENT TO BE PROPOSED AS COVERT WITH ONLY DIRECT PARTICIPANTS WITTING OF COLLABORATION. FEEL THIS HAS GOOD POTENTIAL FOR TYPE OF CONTROL BY KUBARK, FOR PODAM DISTINCTLY UNINTERESTED IN ADDING FUEL TO PAST CHARGES THAT HE "SELLING JAPAN TO PBPRIME." FORESEE NO EXPENSE THIS OPERATION OTHER THAN STAFF SALARIES, POSSIBLE RENT OF QUARTERS TO HOUSE ENTERPRISE PLUS OCCASIONAL 17.8 EXPENSES WITHIN CHIEF JABA DISCRETIONARY POWERS.

5. FEEL SCHEME OFFERS GOOD PSYCH POTENTIAL BEGINNING WITH NEWSPAPER AND POSSIBLY BROADENING TO RADIO AND TV AS CONDITIONS WARRANT. ALSO OFFERS EXCELLENT INTEL POSSIBILITIES ON AN IMPORTANT TARGET IF A TYPE OF DIRECTION CAN BE EXERTED OVER NUMEROUS REPORTERS WHOSE SERVICES COMMANDED BY PODAM.
