OASA Tadao and SHORIKI Matsutaro have entered into an agreement to make SHORIKI Premier following the conservative merger. OASA will first work with MIKI Bukichi to remove KONO Ichiro from power, and then OASA will remove MIKI. OASA discussed this with SHORIKI on 23-24 October 1955 and was scheduled to meet with MIKI on 28 October in the same connection.
