PSYCH PODAM

1. FOLLOWING MAINLY FOR HQS INFO PLUS ANY ACTION DEEMED WORTHWHILE TO TAKE. PODAM, WHO WHEN ENABLING LEGISLATION PASSED THIS WEEK, WILL HEAD NEW STATE COMMISSION ATOMIC ENERGY, HAS BEEN PRESSING THRU ALL MEANS AVAILABLE TO HIM BOTH HERE AND IN PBRIME, FOR DECISION BY ODACID TO SET UP ASIAN NUCLEAR ENERGY CENTER IN JAPAN. ODACID HAS REPLIED TENTATIVE SITE SELECTED MANILA BUT HOPES JAPAN WILL PARTICIPATE AS SPONSOR.

2. [ ] HAS TWICE TELEPHONED IDEN IN PAST WEEK, ASKING IDEN TO EXPLORE AND INTERVENE IF POSSIBLE GETTING CENTER LOCATED IN JAPAN, OR FAILING THAT, TO TRY TO GET PROMISE OF SETTING UP REACTOR HERE, OR OTHER TANGIBLE EVIDENCE ODOYKE SUPPORT JAPANESE ENERGY DEVELOPMENT. SO FAR IDEN HAS APPARENTLY BEEN HELPFUL, BUT STATES CANNOT APPEAR TO BE PRESSING CASE TOO STRONGLY AS MEMBER INTERESTED PRIVATE CORPORATION. PODAM HAS ARRANGED FOR AMB IGUCHI MAKE STRONGEST REPRESENTATIONS ODACID THIS WEEK, IN EFFORT TO GET DECISION FAVORABLE TO JAPAN.

3. PODAM FEELS HAS NECK OUT ON NUCLEAR ISSUE, AND POLITICAL FUTURE INTIMATELY RELATED TO ACHIEVING SOME SUCCESS THIS FIELD DURING TENURE PRESENT CABINET. [ ] FEELS THAT ALTHOUGH THIS ENTIRE FIELD ACTIVITY FAR REMOVED KUCAGE
