1. The television sets for POJACKPOT/1 were shipped from New York on 14 May 1958, aboard the Identity A. They will arrive no later than 14 June. The sets will be delivered to Identity B.
2. A CSA for use of Identity C was approved 11 April 1958. Because his profession is that of a tax attorney, Identity C was extremely busy during this period, so no one was able to meet him until 17 April. After he had been contacted on that date, Identity C made the necessary arrangements with Identity D. Identity D suggested that for an extra \$332.30, the sets would be shipped overland and sent from San Francisco, thereby saving 11 days. At our direction, Identity C agreed, and a check for the total cost of \$4,032.30 was given to Identity C on 22 April 1958. Identity D stated that Identity C would be informed as soon as the sets were ready for shipment. On 24 April 1958, Identity C sent a letter to Identity E, president of Identity B, stating that he would donate the sets as a friendly contribution to the success of color television in Japan. On 14 May 1958, Headquarters was informed by Identity C that Identity D had sent him the information contained in paragraph 1, above.
3. Although the sets will not arrive in time for use as intended, there is nothing further that HIBANK can do either to speed shipment or recover the funds, except that reimbursement will be requested for the extra \$332.30.
