Constitution of Japan Rocketry Association

General Provisions

1. This association is called the Japan Rocketry Association.
2. This association aims at promoting rocketry technique as well as contributing to the diffusion and development of the knowledge about rocketry.
3. The office of this association shall be located in Chiyoda Ward, Tokyo.

Business Lines

4. This association, in order to attain its objective, shall carry out the following projects:
 - 1) Research, study, experiment in rocketry and aid to such activities;
 - 2) Announcement of research achievements by means of lecture meetings and the publication of a bulletin;
 - 3) Collection of literature and data on rocketry;
 - 4) Exchange of technical information with rocketry organizations of foreign countries;
 - 5) Dissemination of rocketry technique; and
 - 6) Other projects deemed necessary by the association.
5. A member of this association ~~shall~~^{must} be a supporter of its principle, a cooperater in its activities, and must have obtained an approval from the association's Board of Executives.~~XXXXXXXXXX~~
6. ^A~~The~~ member shall be a regular member, an associate member, or a special member, and the qualifications for membership shall be provided for in the association's regulations.

- 1) A member must pay in, by the designated date, a membership due as provided for in the regulations. (An honorary member shall be excepted from this rule.)
- 2) In the case of an organization, its representative shall be deemed a special member. However, except for the case of some decision to be made, all the organization's constituents shall be held entitled to ~~xxx~~ equal benefits, with other members, from the association.
- 3) An associate member, in the case of a decision to be made, ~~xxxxxx~~ shall not be eligible to a vote.
7. A member shall be given opportunities of utilizing the information, data, and research products collected by the association and shall be allowed participation in lecture meetings, visiting parties, and other programs to be carried out by the association.
8. A member ~~xxxxxxx~~^{whose} behavior has been found against the principle of the association or has greatly damaged its prestige may be eliminated from the list.
9. This association, if it deems it necessary, can nominate honorary members.
10. This association shall have the following officers:
 - One Representative of the Board of Executives
 - Several Standing Executives
 - Several Executives
 - 2 auditors
 - Several Advisers

11. The Board Representative shall represent the association and, by acting as chairman in its General Meeting, Executives Meeting, and Standing Executives Meeting, shall dispose its affairs.
12. A Standing Executive shall assist the Board Representative in disposing the association's affairs.
13. An Executive shall deliberate on budgets and settlements of accounts as well as other matters to be consulted on by the Board of Standing Executives.
14. An Auditor shall audit all the ~~accounting~~ accounting of the association including its secretariat.
15. An Adviser, if consulted, shall cooperate ~~in~~ ^{by} advising on the management of the association.
16. The method of selecting the officers shall be as follows:
 - 1) The Executives and Auditors shall be elected from among the regular and special members.
 - 2) The Standing Executives shall be elected from among the Executives.
 - 3) The Board Representative shall be elected from among the Standing Executives.
 - 4) The Advisers shall be commissioned as such by the Board Representative after reference to the Board of Standing Executives.
17. The tenure of an officer shall be 2 years, provided that he can be re-elected or re-commissioned. The tenure of an officer filling the vacant post shall terminate ~~with the term~~ at the time when the ~~the~~ remaining term for his predecessor might have expired.

18. A decision in a conference, unless otherwise ruled, shall be made by a majority decision of the attendants and, in case pros and cons are equal in number, the chairman shall have a casting vote.
19. A meeting of the Board of Standing Executives shall be called by the Board Representative.
20. A meeting of the Board of Executives shall be held when proposed by the Board of Standing Executives, and it shall be held, at least, once in 6 months. Besides, if one-fourth or more of the total number of Executives have requested, the Board Representative must hold a meeting of the Board of Executives within one month from that time.
21. A General Meeting shall be held once a year to deliberate on the budget, the settlement of accounts and matters consulted on by the Board of Standing Executives. Besides, if one-fourth or more of the total number of members have requested, an Extraordinary General Meeting must be held within 2 months from that time.
22. The budget as well as settlement of accounts of the association must first be discussed by the Board of Executives and then get approval of the General Meeting.
23. The association, if it deems it necessary, can establish various committees.
24. In order to ~~alter~~ change the association's constitution, an approval by the General Meeting must be obtained.
25. The association, if it seems it necessary, can establish its

local chapter. The constitution of a local chapter shall be given separately.

Secretariat

26. In order to dispose the association's affairs, it shall have its secretariat under the Board of Standing Executives. The regulations for the secretariat shall be provided separately.

Supplementary Provisions

1. This constitution shall be effective as from September 4, 1956.
2. The promoters of this association, ^{at} ~~as~~ the time of its founding, shall be the whole body of Executives.

Minor Regulations

1. The qualifications for membership shall be as follows:
 - 1) A Regular member shall be one who is engaged, ~~in a rocketry job or~~ ^{or} ~~was~~ engaged, in a rocketry job or one who has equal or more knowledge about it.
 - 2) An associate member shall be one who is expected to become a regular member someday, inclusive of one who is yet undergraduate.
 - 3) A special member shall be ~~one~~ an organization representative or an individual who can commit himself to payment of the designated membership due.
2. The initial fee and membership due of a member shall, for the time, be as follows:
 - 1) A regular member shall pay ¥300 as initial fee and ¥1,000 as annual membership due.
 - 2) An associate member shall pay ¥200 as initial fee and ¥600 as annual membership due.

- 3) A special member shall pay ¥50,000 as initial fee and ¥50,000 per unit as annual membership due.
