GENERAL HENRY S. ((DUBAR)) TOLD PRESIDENT SAMUEL ((DOE)) HE HAD TO STEP DOWN TO BRING A POLITICAL SOLUTION TO THE COUNTRY'S INSURGENCY PROBLEM. DUBAR SAID THE AFL COULD NOT DEFEAT NPFL FORCES. HE SAYS HE TOLD THE PRESIDENT EVEN IF THE ARMY RECEIVED INTERNATIONAL ASSISTANCE, LIBERIANS NO LONGER WANTED HIM AS PRESIDENT. HE SAID THERE HAS BEEN TOO MANY ATROCITIES AND "WE HAVE ALREADY LOST OUR FRIENDS, THEY HAVE DESERTED US." THE PRESIDENT TOLD DUBAR HE WOULD AWAIT THE OUTCOME OF THE PEACE TALKS BETWEEN GOL AND NPFL REPRESENTATIVES IN FREETOWN ON 11 JUNE BEFORE HE MADE A DECISION ON HIS NEXT STEPS.
