1. WRANGEL ARRIVED ANMA 14 DEC SPECIFICALLY TO COMPLAIN TO RNINTEGER RE NOSTRIL ACTIVITIES AND CLAIMS HE REPRESENTING ODOYKE. FORTUNATELY RNINTERGER AWAY AND WRANGEL DISCUSSED SUBJECT WITH POLITICAL OFFICER, CONSULAR OFFICER AND [ ]

2. WRANGEL EXTREMELY UPSET, GAVE US PERTINENT CORRESPONDENCE (COPIES MADE) STATES EMPHATICALLY NOSTRIL'S ACTIVITIES AND ALLEGATIONS INJURIOUS NOT ONLY TO TOLSTOY FOUNDATION BUT TO ODOYKE. WRANGEL INSISTS NOSTRIL IN LOW ESTEEM AMONG CIRCASSIANS, AND ALTHOUGH ADMITS SAID MUFTI RECEIVED NOSTRIL THIS PURELY GESTURE OF COURTESY AND NOT EXPRESSION CONFIDENCE NOR WELCOME. SAID'S BROTHER RIFAT REFUSED RECEIVE NOSTRIL, AND IN GENERAL ACCORDING WRANGEL RIFAT'S ATTITUDE REPRESENTATIVE OF CIRCASSIAN FEELING TOWARDS NOSTRIL.

3. WE WELL AWARE NOSTRIL PERSONA NON GRATA WITH SOME CIRCASSIAN ELEMENTS, AND MUCH OF CRITICISM STEMS FROM FORMER WELL ESTABLISHED ANIMOSITIES. NONETHELESS WE VIEW WITH INCREASING ALARM EVIDENCE NOSTRIL'S INDISCRETIONS, BOASTFULNESS, AND CLAIMS THAT HE HAS "SPECIAL" CONNECTIONS. FURTHERMORE HIS REPORTING ON PROMISING CONTACT WITH MUFTI IS TOTALLY INCONSISTENT WITH PRESENT AND APPARENTLY PREVIOUS ATTITUDE MUFTI FAMILY.

THERE IS NO QUESTION THAT IF NOSTRIL REMAINS HIS ACTIVITIES BOUND BECOME SUBJECT OFFICIAL INQUIRES, INASMUCH AS HIS PRESENCE HERE IS INTERPRETED TO BE ON BEHALF "LIBERATION COMMITTEE" NEW YORK, WHICH ACCORDING TO WRANGEL, IS SUBSIDIZED BY ODOYKO, CONCLUSION BEING NOSTRIL ON SPECIAL ODACID MISSION. WE CERTAINLY DO NOT RELISH RNINTEGER GETTING INTO THIS PICTURE.

5. WRANGEL PRODUCED LIST OF ADMITTEDLY FLIMSY EVIDENCE THAT NOSTRIL

- (A) HAS BEEN KNOWN AS MEMBER CP IN RUSSIA,
- (B) AGITATED IN CAMPS IN ITALY AND AUSTRIA FOR REPATRIATION TO RUSSIA,
- (C) HAS BROTHER WHO APPEARS TO HAVE VAGUE CORRESPONDENCE WITH RUSSIA,
- (D) HAD BEEN SEEN LEAVING SOVIET CONSULATE IN BEIRUT,
- (E) WAS SUSPECTED BY PATRICK COGHILL,
- (F) WAS SUBJECT OF RECENT INQUIRES OF PENINSULA.

6. OUR POSITION TO WRANGEL WAS THAT NOSTRIL AS LEGAL RESIDENT U.S. HAS PERFECT RIGHT TRAVEL WHEREEVER HE WANTS, AND THAT WE HAVE NO JURISDICTION OVER HIS ACTIVITIES. WE POINTED OUT THAT IF WRANGEL SHOULD INDEED HAVE SOME SUBSTANTIAL EVIDENCE ON NOSTRIL'S CONNECTIONS WITH SOVS THEN WE WOULD OF COURSE PASS INFO TO ODENVY FOR INVESTIGATION.

7. SINCE IN OUR JUDGEMENT NOSTRIL COMPROMISED HIMSELF SUFFICIENTLY TO PRECLUDE ANY FURTHER USEFUL ACTIVITY ON OUR BEHALF, [ ] INSTRUCTED [ ] TO "FREEZE" NOSTRIL TILL HQS INSTRUCTS US. OUR RECOMMENDATION IS NOSTRIL SHOULD DEPART SOONEST AS (A) MORE SEARCHING INVESTIGATION MAY WELL REVEAL OUR PARTICIPATION AND (B) HE APPEARS TO HAVE INCURED SUCH DISPLEASURE OF MORE INFLUENTIAL SEGMENT CIRCASSIAN COMMUNITY THAT HIS USEFULNESS IN THIS FIELD IS HIGHLY QUESTIONABLE.
