F. AMB HILL DID NOT SIGN JF-3 SEPARATION STATEMENT AS HE INTENDED THE SEPARATION TO BE IN THE US. HOWEVER, HE WAS INSTRUCTED BY RSO ON NUMEROUS OCCASIONS PRIOR TO HIS DEPARTURE NOT TO REMOVE ANY CLASSIFIED OR ADMINISTRATIVELY CONTROLLED MATERIAL FROM THE POST. ARRANGEMENTS WERE MADE FOR HIS SECRETARY TO POUCH SUCH CLASSIFIED MATERIAL TO THE DEPT FOR REVIEW AND POSSIBLE RELEASE. AMB HILL AGREED TO THIS PROCEDURE.
