1. A CUBAN DIPLOMAT STATED [Redacted] THAT STOKELY CARMICHAEL WILL DEFINITELY BE RETURNING TO THE UNITED STATES. THE CUBAN DIPLOMAT DOES NOT KNOW HOW, WHEN, NOR AT WHAT POINT ENTRY TO THE UNITED STATES WILL BE MADE.

2. THE CUBAN DIPLOMAT SAID THAT A SECOND CUBAN DIPLOMAT, ASSIGNED TO THE UNITED NATIONS AND KNOWN TO BE A RANKING CUBAN INTELLIGENCE OFFICER, HAD BEEN ADVISED TO AVOID CONTACT WITH CARMICHAEL. THE UN DIPLOMAT ASSUMED THAT INDIRECT MEANS WOULD BE ARRANGED FOR ANY FUTURE CONTACTS.
