1. ONE HERIBERT HUGO GEORG RAPHAEL VON STREMPER, DPOB 8 MAR 1902 BRLN, WHO POSSIELY IDEN WITH SUBJ REF, WAS A SECY IN THE FOREIGN OFFICE. HE GRADUATED FROM HIGH SCHOOL IN 1919 AND STUDIED LAW AT THE UNIV OF JENA 1919-22. IN 1923 HE ENTERED DIPLOMATIC SVC AS A TECH ASST IN THE FOREIGN OFFICE UNDER DR. V. BUELOW, HEAD OF ITS LEGUE OF NATIONS DEPT. HE PASSED HIS DIPLOMATIC EXAM IN 1926 AND BECAME ATTACHE IN PARI WITH A GERMAN DELEGATION WHICH WAS TO NEGOTIATE A TRADE AGREEMENT WITH FRANCE. DURING 1927 SUBJ WORKED AS 2ND SECY IN GERMAN EMB BELGRADE, AND FROM 1928- TO 1934 AS CHARGE D' AFFAIRES IN CHILE. IN 1934 NSDAP FOREIGN PARTY ORG DEMANDED SUBJ'S RECALL, SINCE HE WAS NOT A PARTY MEMBER. HE WAS THEN ASSIGNED TO WASH AS 2ND SECY, BUT AS RESULT OF NSDAP DEMANDS WAS RECALLED TO GERMANY AND ATTACHED TO THE FOREIGN OFFICE PRESS DEPT, BRLN AS SPECIALIST FOR SOUTH AMERICAN AND ANGLO-SAXON AFFAIRS UNTIL 1937. IN 1938 VON STREMPER WAS ASSIGNED TO WASH WHERE HE REMAINED UNTIL 1942 WHEN HE WAS EXCHANGED. SUBJ RETURNED TO THE PRESS DEPT AND WAS IN CHARGE OF THE NORTH AMERICAN
