2. SUBJ STATED HE EARLY MEMBER SS AND PROTEGE HEIDRICH WHO ASSIGNED HIM TO RSHA WHERE HELD RANK STURMBANNFUEHRER (MAJOR) AT END WAR. CA 48 SUBJ INSTRUMENTAL IN ORGANIZING HILFSGEMEINSCHAFT AUF GEGENSEITIGKEIT (HIAG) WHICH VETERANS ORGANIZATION OF FORMER SS MEMBERS WITH CURRENT MEMBERSHIP 120,000. SUBJ CLAIMS HIS JOB IS CHIEF OF "KAMERADSCHAFTS-ND" WHICH INFORMAL INTEL SECTION OF HIAG.

4. INITIAL IMPRESSION SUBJ EXTREME RIGHT-WING, PROBABLY IDEALISTIC ANTI-COMMUNIST AS CLAIMS. WHILE SEEMED SINCERE IN DESCRIBING HIS ORGANIZATION, SUSPECT HE EXAGGERATING NUMBERS AND ACCESS OF CONFIDENTIAL INFORMANTS. SUBJ CLAIMS TWICE APPROACHED BY CASCOPE BUT NOT INTERESTED IN COOPERATING WITH CASCOPE BECAUSE OF ITS OFFICIAL ASSOCIATION WITH BRANDT GOVERNMENT. SUBJ STATED HE WOULD BE WILLING COOPERATE WITH BKTRUST.

5. PLAN ADDITIONAL MEETINGS WITH SUBJ TO OBTAIN INFORMATION HE WILLING AND ABLE PROVIDE ON HIS GROUP AND SOURCES. WILL REQUEST TRACES THESE INDIVIDUALS AND POUCH FULL RESULTS DEBRIEFING WHEN COMPLETE. MADE CLEAR TO SUBJ BKTRUST CONTACT WITH HIM INFORMAL AND AT HIS REQUEST AND THAT HE SHOULD NOT INDICATE TO OTHER HIAG MEMBERS THAT ^{BKTRUST IN} ~~BAWFRIBWW~~ ANY SORT LIAISON WITH HIS GROUP. SUBJ AGREED NOT MENTION CONTACT WITH OTHER HIAG OFFICIALS.
