1. On 1 January 1968, [redacted] 3.3(h)(2)
 [redacted] ordered NGUYEN THI NHU to go to HOC MON District, GIA DINH Province, to wait for him there. Arriving in HOC MON on 3 January [redacted] had to wait until 30 January when she met [redacted] who advised her that she was now a member of the [redacted] then ordered [redacted] to return to SAIGON to carry out a mission.
2. Arriving in SAIGON by bicycle at noon, 31 January, [redacted] went to meet a contact at the intersection of Hai Ba Trung and Hong Thap Tu Streets. She had been instructed to hold a red handkerchief in her hand as a recognition signal. A boy approached her as she waited on the corner and gave her a note instructing her to go to the intersection of Nguyen Tri Phuong and Hong Bang Streets in CHOLON at 1800 hours to pick up a package which she was then to deliver to the intersection of Le Van Duyet and Hong Thap Tu Streets at 2000 hours. She was to leave the package in front of a clinic at the Le Van Duyet and Hong Thap Tu intersection, and was to return to HOC MON the following day to await future orders. [redacted] 3.3(h)(2)
 [redacted] stopped at a police checkpoint and was arrested at 2000 hours, 31 January 1968 on Nguyen Thien Thuat Street. When the package was brought to Precinct Three Headquarters, a Soviet rifle was found inside. NHU disclaimed all knowledge of the contents of the package. 3.3(h)(2)
