- 3. THE MILITARY TRIBUNAL INVESTIGATING TIMERMAN HAS INFORMED HIM THAT NO SUBVERSIVE CHARGES WILL BE FILED AGAINST HIM. DECISION, WHICH HAS NOT YET BEEN MADE PUBLIC, CAME AFTER TIMERMAN TESTIFIED FOR 13 HOURS ON SEPTEMBER 29. AS A RESULT, HE CAN EITHER BE TURNED OVER IN TO THE CIVIL COURTS FOR PROSECUTION OF "ECONOMIC CRIMES", HELD UNDER STATE OF SIEGE EXECUTIVE DETENTION OR RELEASED OUTRIGHT.

Military Tribunal Clears Timerman of Subversive Charges

A preliminary military tribunal informed ex-La Opinion Editor Jacobo Timerman that there are no subversive charges against him. The decision, which has not yet been made public, came after Timerman testified for 13 hours on September 29. As a result, he must now be turned over to the civil courts for prosecution of "economic crimes" or released outright. A final decision on this is expected shortly. According to one source, the Jewish community feels he will soon be released. In any case it now appears that he will not have to face an official military tribunal.

Hector Timerman reported that his father was returned to Buenos Aires a week ago. The family visited him here October 2. He also reported that the tribunal asked his father if he was Patricia Derian's cousin. Hector added that Timerman doesn't expect to get the paper back. claims he doesn't want it back but does want to leave Argentina ASAP.
