In "optember 11, 1953, T-2, of known reliability, furnished a booklet entitled, "Flood Bath in Rumania", published in the "Record", a news bulletin, by the Trited Armanian Jews of America, 110 West With Street, New York, New York,

The booklet is concerned with the massacre of thousands of Jews by the tree Swardist in January, 19hl.

Two pointed out that on page 15 of instant booklet, there appears a photograph of the Eubject, VEHEL TOTAL, receiving the eath of allegiance from the from quardists. This photograph identified TRIFA as being the 5th individual from the right.

In 19th, according to G V ha, There contends, in his "Curriculum Vitae" that he was transported to Dachau at Vienna because of the Gestapo demanding that he join the German Army to fight against the Communists and to collaborate with a government in the process of being formed.
