1. AT MEETING 20 JUNE WITH CASCOPE SECURITY REPS, WE MENTIONED HQS CONCERN REF C AT POSSIBLE DUPLICATORY OR FABRICATED REPORTING FROM HUNGARY AND JUGOSLAVIA. TIED THIS IN WITH LONG AND UNSAVORY HISTORY OF URBAN AND VEGH IN PEDDLING THEIR INFO TO ALL COMERS, AND PROVIDED SEVERAL RECENT CASCOPE O.B. REPORTS AS EXAMPLES OF TYPE OF INFO WHICH COULD EASILY COME INDIRECTLY FROM SUCH FABRICATORS.

DID NOT MENTION OR /CASCOPE COOPERATION, BUT COINCIDENCE THAT URBAN CURRENT EMPLOYER WAS ITALIAN MADE POINT VERY CONVENIENT

2. INCIDENTALLY, CASCOPE STATED THAT JOSEPH VEGH EMPLOYER WAS NOT ITALIAN BUT ANOTHER N.A.T.O. SERVICE, WHICH IN OUR OPINION LEAVES THE FRENCH AS LOGICAL PARTY.

CASCOPE HUNGARIAN DEBRIEFER IMRE KLEIN, HIS COHORT JOSEF VEGH AND NOW 75 YEAR OLD JOSEF ADOLPH URBAN (FORMER CASCOPE OPERATOR DROPPED IN 56) HAVE BEEN PICKED UP BY WEST GERMAN AUTHORITIES.
