VIETH, WERNER  
 THE TRANSFER OF SCHUETZ TO THE TOP JOB IN THE ERMITTLUNGSREFERAT MADE IT ALMOST IMPERATIVE TO MOVE WERNER VIETH (DPOB: 19 JANUARY 1914) IN BRIDGE TO ANOTHER POSITION. VIETH HEADED ONE OF THE TWO SECTIONS IN THE ERMITTLUNGSREFERAT AND THUS WOULD HAVE BEEN SUBORDINATED TO SCHUETZ, BOTH JUNIOR IN RANK AND IN TIME IN SERVICE AT THE SG. VIETH, AS WE POINTED OUT IN REFERENCE, HAS ALWAYS APPEARED TO LACK NOT ONLY ABILITY BUT ALSO AMBITION AND INTEREST FOR HIS JOB. HE RECENTLY CO-AUTHORED A BOOK OF LIGHT VERSE AND APPEARED TO PURSUE THIS ARTISTIC ENDEAVOR WITH FAR MORE ENTHUSIASM THAN HE DID HIS JOB. FURTHERMORE, HE HAD NOT ENDURED HIMSELF TO HIS SUPERIORS BY HIS QUESTIONABLE HANDLING OF HIS INVOLVEMENT IN THE ROSALIE KUNZE AFFAIR, AND DR. BRUECKNER MAY THUS HAVE SEIZED UPON THIS OPPORTUNITY TO MOVE HIM OUT OF THE SG. VIETH WAS TRANSFERRED TO THE BKA IN WIESBADEN, WHERE HE IS FILLING THE JOB TO WHICH SAEVECKE HAD BEEN ASSIGNED IN THE NACHRICHTENABTEILUNG, HANDLING CAPITAL CRIMES SUCH AS HOMICIDE, NARCOTICS, ETC. SAEVECKE HAS BEEN SUSPENDED FROM DUTY. HE IS ON LEAVE AWAITING THE OUTCOME OF THE INVESTIGATION. HE WILL PROBABLY BE THE SUBJECT OF A DISZIPLINARVERFAHREN, BUT WHATEVER THE OUTCOME HIS CAREER WOULD APPEAR TO BE RUINED AND THERE IS LITTLE CHANCE THAT HE WILL EVER RETURN TO GOVERNMENT SERVICE.
