A field investigation was conducted on above named subject individual by [redacted] in accordance with Security Memorandum No. 7. Results of these checks are given below:

1. A search of the CIC central and local files, KPD and subversive files revealed the following information:

"Date of Birth: 6 February 1921, Berlin, Germany. The following is a summary of information extracted from an interrogation report, Headquarters 1st Division, Civilian Internment Camp No. 22, dated 24 March 1947.

Education: Volksschule Berlin-Treptow 1927-1931
Oberrealschule Berlin 1931-1939

Military Service: Subject was a member of NJ from 1933-1939 where he held the rank of Kameradschaftsführer. He was also a member of the Waffen SS from 1939-1945 where he held the rank of Obersturmführer in 1945.

Details of Arrest: Subject was arrested on 25 March 1947 by the 118th MID charged with being Waffen SS Obersturmführer. No information is available showing when subject was released."

2. A search of the EUCOM Intelligence Division files revealed no information.

3. The EUCOM CID criminal and fingerprint files were checked and revealed no information.

4. The DAD files were searched and contained the following information: (MGKA-25135, 15/12/50)

"1. There were no traces in our files on subject.

"2. There were two traces on individuals whom may be identical with subject's father as follows:

a. LHM9702, dated 8 January 1947, listed one Karl VOIGT as being a member of the KVFD 28-6-46; in the transport business, and living at Staffeckstr. 45, Berlin.

b. The same report listed one Karl VOGT as a member of the KVFD 28-6-46, and an actor. He resides at Kaiserdamm 5, Berlin.

5. A check of the Austrian ODI files revealed the following information, which may or may not pertain to subject:

"Individual, same name, is recorded in the general files on card index #128099 as being born 1921, former Abschr employee (1945) reported arrested in Italy in June 1945. Reported with Abschr Ast, Vienna (Feb 1945)"
