1. ON APRIL 30, THE SENATE ADOPTED BY VOICE VOTE THE RESOLUTION AT PARA 2, URGING THE ATTORNEY GENERAL TO ACT ON **KURT WALDHEIM'S** STATUS. THE RESOLUTION WAS SUBMITTED BY SENATORS WILSON, D'AMATO, QUAYLE, GORE, HAWKINS, BURDICK, HECHT AND LAUENBERG.

2. BEGIN TEXT:

WHEREAS THE UNITED STATES ABHORS THE CRIMINAL BEHAVIOUR AND ATROCITIES OF THE NAZIS DURING WORLD WAR II,

WHEREAS IT IS THE POLICY OF THE UNITED STATES TO VIGOROUSLY PURSUE THE SEARCH FOR AND PROSECUTION OF NAZI WAR CRIMINALS SINCE WORLD WAR II,

WHEREAS THE UNITED STATES STRICTLY ABIDES BY THE POLICY OF EXTRADITION TOWARD WAR CRIMINALS,

WHEREAS THE UNITED STATES IS COMMITTED TO A POLICY OF SECURING AND ENHANCING HUMAN RIGHTS AND INDIVIDUAL

DIGNITY THROUGHOUT THE WORLD,
