1. TAX REFORM: THE GOVERNMENT'S TAX REFORM PROJECT CONTINUES TO BE A FOCUS OF DISCUSSION. (PRINT AND ELECTRONIC MEDIA) FINANCE MINISTER LACINA AND UNDERSECRETARY DITZ EXPRESSED THEIR HOPES YESTERDAY OF A RAPID AGREEMENT ON THE TAX REFORM PLANS THEY HAVE WORKED OUT. THERE IS, HOWEVER, STILL A FINANCING GAP OF 6.5 TO 8 BILLION SCHILLINGS. THE SOCIALIST PARTY CALLS FOR A TAX ON CAPITAL INCOME, WHILE THE CONSERVATIVE PEOPLE'S PARTY FAVORS AN "ENERGY TAX". CHANCELLOR VRANITZKY AND

2. WALDHEIM CASE: YESTERDAY AFTERNOON, SIX MEMBERS OF

- THE INTERNATIONAL HISTORIANS' COMMISSION INVESTIGATING KURT WALDHEIM'S WARTIME PAST VISITED THE PRESIDENT AT HIS HOME TO INTERVIEW HIM AS A WITNESS. THERE HAD BEEN SOME UPHEAVAL WHEN IT BECAME KNOWN THAT WALDHEIM WAS SUPPLIED WITH A LIST OF QUESTIONS TWO DAYS PREVIOUSLY. (KURIER, P.2) ONLY A FEW HOURS BEFORE YESTERDAY'S OFFICIAL FINAL INTERVIEW STARTED, AN "UNNAMED HIGH-RANKING OFFICIAL" OF THE U.S. DEPARTMENT OF JUSTICE EXPRESSED HIS "OUTRAGE" AT THE FACT THE WALDHEIM "HAD BEEN SUPPLIED WITH THE QUESTIONS IN WRITING AT THE BEGINNING OF THE WEEK." APPARENTLY THE U.S. DEPARTMENT OF JUSTICE HAD IMAGINED THIS FINAL INTERVIEW TO BE A SORT OF ROUGH "CROSS-EXAMINATION". THERE WAS EVEN TALK OF A "BETRAYAL" BY THE COMMISSION, AN INSINUATION WHICH WAS REJECTED FIERCELY BY COMMISSION. CHAIRMAN KURZ. HE DENIED EXPRESSLY HAVING PROVIDED AN OPPORTUNITY FOR "WHITEWASHING" WALDHEIM. HE SAID "A BRIEF OUTLINE OF QUESTION AREAS WAS GIVEN TO SPEED UP THE INTERVIEW AND BE ABLE TO GET INTO PROBLEMATIC DETAILS WITHOUT DELAY." KURZ CALLED THE INTERVIEW "USEFUL AND TOUGH." (NEUE KRONENZEITUNG, P.3)
- 3. AUSTRIAN CONSUL IN NICARAGUA: THE APPOINTMENT OF THE WEST GERMAN BUSINESSMAN GERHARD MIELKE AS AUSTRIAN HONORARY CONSUL IN NICARAGUA PLANNED BY FOREIGN MINISTER MOCK IS UNDER ATTACK AGAIN. AFTER A TEN-MONTH DELAY, MANAGUA HAS GIVEN A TENTATIVE AGREEMENT, BUT DEVELOPMENT AID ORGANIZATIONS AND SPOE PARLIAMENTARY REPRESENTATIVES ARE OPPOSING MIELKE'S APPOINTMENT ON THE GROUNDS THAT HE IS A DECIDED OPPONENT OF THE PRESENT NICARAGUAN GOVERNMENT AND SUPPORTER OF THE SOMOZA DICTATORSHIP. (NEUE ARBEITERZEITUNG, P.7)
- 4. LAUDER'S ART EXPORTS: FORMER U.S. AMBASSADOR LAUDER'S ART EXPORTS CONTINUE TO EXCITE SOME MEDIA ATTENTION. THE WELL-KNOWN COLUMNIST NIMMERRICHTER WRITES THAT LAUDER'S ART EXPORTS ARE "A SHAME" AND SAYS: "THE ASSIDUOUS 'ART COLLECTOR' LAUDER IS NOT SO MUCH TO BLAME FOR THIS FULL-FLEDGED SCANDAL AS THOSE SPINELESS AND SYCOPHANTIC AUSTRIAN CIVIL SERVANTS, WHO SHOWERED LAUDER WITH EXPORT PERMITS, BECAUSE THEY MISTAKENLY BELIEVED THIS TO CONTRIBUTE TO IMPROVED AUSTRIAN-AMERICAN RELATIONS. NO AUSTRIAN CITIZEN OR FOREIGNER WITHOUT SPECIAL PRIVILEGES WOULD EVER HAVE GOT THOSE PERMITS!" (KRONENZEITUNG, P.6) THE NEWSWEEKLY "WOCHENPRESSE" PUBLISHED AN INTERVIEW WITH LAUDER IN WHICH HE SAID THE ACCUSATIONS "HAD NO OTHER REASON" THAN POLITICAL REVENGE FOR HIS CRITICAL REMARKS ON ANTI-SEMITISM IN AUSTRIA, AND AFFIRMED THAT HIS EXPORTS WERE "COMPLETELY IN LINE WITH LEGAL PROVISIONS."
