- 2. "ABRAHAM KALINSKI, NHO ALLEGES TO MAVE SERVED IN THE SAME SOVIET PRISONS AS RADUL MALLENGERG IN THE 1950'S MILL COME TO STOCKHOLM TO ELABORATE ON HIS MALLENGERG CONNECTIONS. SHEDISH MFA OFFICIALS WHO HAVE DISCUSSED THE WALLENGERG AFFAIR WITH KALINSKI IN MEW YORK REGARD HIM AS A MOST CREDIBLE WITNESS. IT WAS KALINSKI'S TESTIMOMY GIVEN TO GOS OFFICIALS THAT FORMED THE BASIS FOR SHEDEN'S FIRST DEMARCH IN 14 YEARS TO THE SOVIETS ON THE MALLENGERG CASE.

KALINKSI ASSERTS THAT SHEDISH OFFICIALS SHOULD DEMAND TO MEET WITH SUCH WITHESSES AS KUPRIANOV, JAN KAPLAN (AN ELDERLY SOVIET JEW MHO MAS RECENTLY REARRESTED AFTER HAVING TOLD HIS DAUGHTER IN ISRAEL BY TELEPHONE THAT HE MET A SWEDE IN PRISON IN 1975 WHO HAD SEEN HELD FOR 30 YEARS);

- 5. "FM HANS BLIX, COMMENTING ON THE KALINSKI REVELATIONS, SAID THAT THE GOS MUST ACT IN SUCH A MAY AS BEST TO PROMOTE CHANCES OF ACHIEVING MALLEMBERG'S RELEASE. BLIX NOTED THAT NO OTHER CASE OF ITS KIND HAS BEEN ACCORDED MORE PUBLICITY NOR HAS RECEIVED MORE DIPLOMATIC ATTENTION THAN THAT OF MALLEMBERG.
