2. EMBASSY HAS NOT BEEN APPROACHED ON BIERMAN'S ARTICLE, BUT IT WAS QUERIED ON SUBJECT CASE ON JULY 20 BY AMCIT HARVY ROSENFELD WHO WAS IN BUDAPEST RESEARCHING HIS "ROOTS". ROSENFELD VISITED EMBASSY AND SOUGHT TO ENLIST ITS ASSISTANCE IN DOING ADDITIONAL RESEARCH ON JEWISH HOLOCAUST, INCLUDING FATE OF SKEDISH DIPLOMAT WALLENBERG. (RUSENFELD, A COLLEGE PROFESSOR, PLANS TO ARTIE AN ARTICLE, POSSIBLY A BOOK ON THE MOLOCAUST). ROSENFELD PRESENTED TO EMHOFF A COPY OF A LETTER FROM CONGRESSMAN KEMP (NY). ACCORDING TO THE LETTER, DATED JUME 28, KEMP HAD ASKED HUNGARIAN AMB ESZTERGALYDS TO PROVIDE "ADVICE AND ASSISTANCE" TO RUSENFELD IN MEETING

KITH HUNGARIAN OFFICILAS "REGARDING THEIR EFFORTS TO COMMEMORATE THE HOLOCAUST'S VICTIMS. NEMP, ACCORDING TO ROSENFELD, DID NOT RECEIVE A REPLY FROM ESZTEPGALYOS PRIOR TO HIS (ROSENFELD'S) DEPARTURE FROM U.S.

- ROSENFELF ASKED IF EMBASSY COULD ARRANGE MEETINGS WITH GON MEN AND CHUNCH AFFAIRS OFFICIALS, SAYING THAT HE HAD ALREADY BEEN IN TOUCH WITH JEWISH COMMUNITY LEADERS IN BUDAPEST, INCLUDING DH. (MRS). SZEIFERT, THEY "KNEW NOTHING ABOUT WALLENBERG". EMBOFF ADVISED U.S. DESK OFF AT MFA OF THE OVERALL NATURE OF ROSENFELD'S RESEARCH EFFORT AND ASKED IF HE COULD PUT ROSENFELD IN TOUCH AITH AFPROPRIATE OFFICILAS OF GOM OFFICE FOR CHURCH AFFAIRS. DEJK OFFICER AS INITIALLY MESITANT PLEADING SHORT NOTICE, VACATIONING PERSONNEL, ETCHN EUT SAID HE KOULD CALL BACK. IN VIEW OF ROSENFELD'S SHORT TIME HERE (ABOUT A WEEK) EMBOFF AGAIN CALLED DESK OFFICER, MHO SAID HE WAS STILL MORKING ON MATTER AND THAT HE HAD NO WORD FROM WASHINGTON ON THE KEMP-ESZTERGALYOS CORRESPONDENCE. ROSENFELD, APPAPENTLY FRUSTRATED, APPRECIATED EMB'S EFFORTS AND SAID HE WOULD VISIT SMEDISM EMBASSY PRIOR TO DEPARTURE.
- ACCORDING TO SWEDISH EMB OFF (GANSLANDT) ROSENFELD VISITED SAEDISH EMBASSY BUT WAS TOLD SAEDISH EMBASSY HAD NO DOCUMENTATION ON MALLENBERG CASE AND REFERRED HIM TO STOCKHOM MFA.
- COMMENT: SENSITIVITY OF GOM TO WALLENBERG CASE MOST PROBABLE REASO: FOR MFA'S FOOT-DRAGGING ON ROSENFELD'S REQUEST. THE HUNGARIANS CLEARLY DO NOT WANT TO TOUCH THIS CASE, OVER WHICH THEY HAD NO CONTROL WHEN IT OCCURRED AND THE MEMORY OF WHICH IS AN EMBARRASSMENT. ABOVE REPORTED SO THAT DEPARTMENT AND OTHER ADDRESSEES HAVE COMPLETE INFORMATION ON DEVELOPMENTS IN BUDAPEST, EVEN IF THEY ARE ONLY PERIPHERAL TO MALLENBERG CASE. WILGIS
