WE WOULD APPRECIATE ANY AUTHORITATIVE INFORMATION WHICH WE HAY PASS TO HIM. A TEAR LINE WOULD BE PREFERABLE. HOVEVER. WILL DE GLAD TO PASS IT ORALLY IF NEEDED. THANKS.
