1. WE HAVE UJ DREADFUL REQUEST FOR TEMPORARY TRAVEL DOCUMENT IN THIRD ALIAS LISTED PAT TO WOLA-8003. ALLEGEDLY PLANS TO USE FOR OPERATIONAL TRIPS TO VIENNA. WITHIN PAST TWO WEEKS HE REQUESTED THROUGH ZIPPER SO THAT PDE ARRANGE AIR TRIP. TRIP APPARENTLY WOULD HAVE BEEN GENERAL SEARCHING ACTIVITIES, PERHAPS MEETING WITH OPERATIONAL CONTACTS NOT KNOWN. PDE DECLINED AIR TRIP ON BASIS WE INTEND LIMIT PRESENT AIR COMMITMENT TO ONLY ACTUAL CASES UNTIL OTHER AIR FACILITIES AVAILABLE.

2. HAVE TAKEN STEPS GETA INTO, AS CANNOT REASONABLY REFUSE. UJ DREADFUL WILL UNEXPECTEDLY AGAIN ATTEMPT PROMOTE TRIP VIENNA AS SOON AS POSSIBLE. HAVE POINTED THIS OUT TO ZIPPER IN CONTEXT UJ DREADFUL CASE AND HAVE ASKED TO BE INFORMED HIS INTENTIONS AS SOON AS ZIPPER AWARE.

3. OBVIOUSLY AGGRESSIVE CONDUCT OF CASE WOULD INVOLVE ALLOWING HIM TRAVEL VIENNA AND THEN SURVEILLANCE. HOW GOOD ARE AVAILABLE VIENNA SURVEILLANCE FACILITIES? IF CAREFUL CLOSE SURVEILLANCE FEASIBLE, WHAT NOTICE WOULD VIENNA NEED TO MY EYE FOR YOUR INFO, ALIAS MERKER STATED CONFIDENTLY ZIPPER COULD RLY ON VIENNA SURVEILLANCE, BUT WE MOST SURE. AT SAME TIME MERKER ASKED OUR FACILITIES TO WHICH I GAVE NON COMMITAL REPLY.

4. MERKER INFORMED I AT ZIPPER STAFF MEMBERS HAVE RECENTLY NOTICED SIGNS OF DEFINITE UNCOMFORT IN UJ DREADFUL, BUT THIS OF COURSE POSSIBLE FALSE IMPRESSION GAINED ONLY DUE INTENSITY OF SCRUTINY ON PART OBSERVERS. MERKER ALSO STATED UJ DREADFUL HAS REPORTED TO ZIPPER HE HAS OPPORTUNITY AND MAY TAKE TRIP TO U.S. DETAILS NOT AVAILABLE.

5. POD HAS FAIRLY DEFINITELY DECIDED NOT INCLUDE UJ DREADFUL IN UJ BROSHKY (ALSO RCVD DROSHKS) COMPLICATED ENOUGH. SECOND UJ DREADFUL CARRIAGE WITHOUT SIGNIFICANT CHANGE IN CASE AND IN ABSENCE EFFECTIVE HOLDING AND INTERROGATION FACILITIES SEEMS LIKELY BLOW CASE TO UJ DREADFUL WITHOUT PROSPECT BREAKING HIM AS HE WELL AWARE OUR HANDS TIED LEGALLY IN ABSENCE AIRTIGHT CASE.
