1. FOLLOWING UNSIGNED CRYPTIC TELEGRAM RECEIVED BY SUBJECT FROM HAMBURG UNDER TRUE NAME AT 33 ELISABETHSTR, MUNICH, ADDRESS: BIN SEHR BETRUET ACER 26 POINT 27 PYRMONT AB 28 POINT MITTAGS BIS 30. MITTAGS (POSSIBLY MITTAGS) ABWESEND STOP VORSCHLAGE TERMIN 30. UNTERSCHRAENKT BIS 9 MAI HERZLICHSTE GRUESSE.

2. MESSAGE APPARENTLY RECEIVED BY SUBJECT ABOUT 2300 HOURS 21 APRIL 1953.

3. SINCE UNDEADFUL HAS NO LEGITIMATE OPERATIONAL ACTIVITIES KNOWN US IN HAMBURG AREA BELIEVE ATTEMPT THROUGH ANY AVAILABLE SOURCE TO DETERMINE SENDER OF TELEGRAM JUSTIFIED FROM SECURITY POINT OF VIEW. ASSUME EVEN THOUGH TELEGRAM UNSIGNED, SENDER HAD TO LEAVE SOME NAME WHEN FILING MESSAGE. IF YOU AGREE, PLEASE TAKE NECESSARY ACTION.

4. PERHAPS FAR FETCHED, BUT CONNECTION IN HAMBURG TO ] OF EGQA-14850 WOULD BE MOST INTERESTING BREAK IN CASE.
