SUBJECT: UJDREADFUL

1. Information possibly pertinent to Subject is contained in VIENNA CIC report Nr. AR-V-36311 of 19 August 1953. Source of the report is actually Karl CVRK aka STEINHARDT, but the report was obtained from Austrian Police, and represents only a statement which CVRK made to the Austrian Police when he was detained in February 1953.

2. CVRK allegedly worked for the VOGELER Committee, having been hired by ~~Anton~~ KANDRAK Harry WIEDERER. These two and an Anton KANDRAK were in SALZBURG up to Fall 1952. Then WIEDERER returned to the US, and KANDRAK emigrated to Canada.

3. In his statement to Austrian Police, CVRK named ~~several~~ people who, he claimed, worked for either Soviet or Czech Intelligence. They were:

- ← Cover Many UJDREADFUL*
- a. Erich WANDT, General Delivery, MUNICH - actual whereabouts unknown, has worked for the Russians for two years.
  - b. Josef MICUDIK - CIS - (G-2 USFA file confirms)
  - c. fnu KOLOKOFF, Major in Soviet Army, Chief SRIS in VIENNA. No record G-2 USFA.
  - d. fnu KUZNECOV works with KOLOKOFF. G-2 USFA says man this name is head of SRIS school in BADEN bei WIEN.
  - e. fnu ZVONIKOV. G-2 USFA file states one George ZVONIKOV is liaison man to SRIS VIENNA.
  - f. fnu ANDEJEV - G-2 USFA holds one ANDREEV with office located on Graben VIENNA (TEXTAS firm) is alleged SRIS.

- g. Alfred BAUER, PERG, Upper Austria, Gendarmerie inspector, allegedly SRIS. G-2 USFA no recordd.
  - h. Josef GROISS, Gendarmerie Inspector, SANDL, Upper Austria. Alleged SRIS. No record G-2 USFA.
  - i. LAMATSCH or LAMAC, VIENNA, Telephone Nr R-29414. (Whether CIS or SRIS not specified). G-2 USFA - CCG trace on Dr. Karl LAMAC, WIEN I, Falkenstr. 6, made telephone call 2 November 1950 to man in England. Man in England talked about another man who had disappeared, LAMAC stated the man was in PRAGUE under arrest, would send word (to man in England) about it. (See also 25.50RO report.)
  - j. fnu KUBASTA, works for SRIS. No record G-2
  - k. fnu ZENZ - no info
  - l. Anton RIEDMANN - Supposed SRIS agent. (G-2 apparently carries him as associate of CVRK).
  - m. fmu SCHMIDT - no record.
  - n. fnu KABELKA - CIC has doossier on him, content unknown.
  - o. fnu DOBRY - CIC has dossier, content unknown.
  - p. Un-named (in notes from SOB) person, possibly one of those listed above, alleged to be SRIS agent in INNSBRUCK. French have confirmed they believe he is Sov agent too.
4. I will try to locate original CIC report and get copy.
5. I wrote D/F to G-2 USFA asking CIC to locate and query CVRK to determine basis of accusations against all above, but told G-2 we were especially interested in trying to identify WANDT and reason CVRK says is SRIS agent.
