2. REPORT OF FINDINGS  
SUMMARY OF INVESTIGATION: **NOT SUITABLE FOR MICROFILM**

To obtain background information concerning the intelligence activities of SUBJECT and the NEMK (Magyar Harcosok Bajtársi Közössége - Hungarian Warriors Comradeship Federation), and to establish if there are any security considerations involved by his continuance employment with the USFA Engineers Photo-Topo Unit.

File No. IND/094/52), Subject: "Lajos KSDAS", with attached page of specific questions, the answers of which are asked to be prepared in writing by SUBJECT and with attached Personal History Statement to be completed on SUBJECT and submitted as a separate paper, all transmitted via Comment No. 2, USFA, GR, Opus, dated 2 April 1952 and Comment No. 3, Headquarters 410th SIG Detachment (Opus Case No. 4506), dated 7 April 1952.

RESULTS OF INVESTIGATION:  
On 31 April 1952, SUBJECT was interviewed in the Hungarian language through an interpreter (Informant 3732). Agent's Note, Paragraph 2, Comment No. 2, of basic Disposition Form states that "... It is understood that SUBJECT possesses a good knowledge of English...". According to SUBJECT's own statement he speaks no English but understands a limited amount. SUBJECT stated essentially the following concerning past contacts with U.S. Agents and his fears toward cooperating in furnishing the above-requested information:

During the fall of 1948 General Liaison SAKO, head of the WDE had procured a written memorandum in the copy and had given it to Miklos KORPCSEY, the Adjutant and close associate of SAKO for personal delivery to GIC in Budapest. KORPCSEY was trained that he followed SAKO's instructions. The memorandum

account of better information concerning the foundation and organization of the "KORFAS" Movement all of which was offered to the U.S. Forces for exploitation. During that time it is known that HADAS was in contact with one Peter (?) ZAKOVIC and one (now) PISZEL-SCHNIDT, a former AVH officer who defected to the West. The U.S. Forces rejected ZAKO's proposal of the "KORFAS" Movement. ZAKOVIC and PISZEL-SCHNIDT later immigrated to the United States. During 1951 the Hungarian National Council in New York City and Washington openly attacked the HBER. In this attack one of the main points of the accusation was that the HBER is identical with the "KORFAS" Movement. The attack brought out information which only could have been obtained from ZAKOVIC, who more than likely received it from contact with the Americans. The attack gave the exact information concerning the organization of the "KORFAS" Movement as set forth in this memorandum to CIC during 1948. (George's Note: HADAS admitted that the above was based solely on a conversation between him and ZAKO in late November 1951.)

Also during November 1951 ZAKO told HADAS that KORFONAY had been in contact with the U.S. Forces in Salzburg and sometime during those contacts KORFONAY had denounced the entire HBER and ZAKO. According to ZAKO the information of KORFONAY's denunciation came immediately back to ZAKO through what ZAKO called his American contacts. ZAKO claimed to be in contact with an American group himself and thereby the information which was furnished by KORFONAY was channeled to ZAKO. (Agent's Note: HADAS is of the opinion that KORFONAY actually denounced ZAKO personally to the U.S. Forces and ZAKO has "played" the matter up to other HBER members as an attack or denunciation of the entire HBER in an effort to "neutralize" KORFONAY. HADAS actually was of the opinion on 21 April 1952 that the leak to ZAKO came from CIC or another U.S. Agency; however, after receiving a letter from KORFONAY on 22 April 1952, HADAS is of the opinion that the leak came from a Hungarian refugee, Iosaf HAMVAN, who resides in Switzerland. The content of the letter from KORFONAY is enclosed below.)

ZAKO has a contact in the United States, one Andre SZINAY, a former Hungarian General Staff captain who is the military advisor of Tibor KORFOGAT head of the Military Affairs Section of the Executive Committee of the Hungarian National Council. ZAKO is in frequent correspondence with SZINAY. ZAKO indicated to NADAS during November 1951 that he (ZAKO) had received information from SZINAY in the United States. This information was of a derogatory nature concerning the KUIDL and had been furnished to the U.S. Forces by KORFOGAT during 1951. (Agent's Note: Again KORFOGAT's letter to NADAS on 22 April 1952 changed his mind concerning the above and he does not believe that such actually happened.) (F-5)

2. On 21 April 1952 SUBJECT was given a copy (in Hungarian) of the list of questions which is attached to reference Disposition Form by the Undersigned. SUBJECT was requested to submit answers in writing to the above-mentioned questions. After much deliberation and explanation of his reason why he feared to cooperate, which is mentioned in paragraph 1 above, SUBJECT consented to cooperate and attempt to have the answers prepared by 26 April 1952. SUBJECT contacted this Agent on 26 April 1952 and submitted the following answers to questions mentioned above: (Agent's Note: The answers were submitted in Hungarian and then translated into English by Informant 3702. A photostatic copy of the answers as submitted by SUBJECT is attached to the original and file copy of this report as Exhibit "I". The original interrogations as submitted by SUBJECT are attached to the file copy of this report.)

Complete Details on Past and Present Ties to German Intelligence Personnel

"I served in the past (prior and during World War II) as a General Staff Officer in the "material" and "operational" branches and as such I had no direct contact to German

Intelligence Officers or personnel. Although from 1943 to 1948 as the chief of the Hungarian Army General Staff's Operations and Planning office I had an operational acquaintance with the work of the Hungarian Army Intelligence Section (what, where and what should be explored, etc.). Even though I was the one who mainly utilized the result of this work, I did not have anything to do with the technical execution of operations of the Intelligence Section. Therefore, I was only connected to members of the German Army General Staff who also served only in operational and planning branches. First of all I was connected to General Hans von GREIFFENBERG who represented the German Army General Staff in Hungary as a "Plenipotentiary General". Later I had contacts with General Helmut von DUECKEN who was the Chief of Staff with the Army Group South (Heeresgruppe Sued); this was when the front had moved to Hungary and the operational employment of Hungarian troops was subordinated to the Germans. During my visits at HITLER's Headquarters I accompanied the permanent Chief of Staff of the Hungarian Army (Janos Szombathelyi VOEROS). I had discussions with the chiefs of Operations Branches (OB - General WASHINGTON, OBH - General HEISINGER and later General FRIE). In the near past (since World War II) I have had no contact to the Germans whatsoever".

General's Duties on Front and Present Ties to Various Emigre Groups Active in the Intelligence Field

"I did not look for such ties and did not have any. Partially because from a Hungarian viewpoint there were only executive positions with no directive or evaluating possibilities existing. The latter positions were held by personnel of the Western Powers who finance these intelligence activities. The other reason was, that even the executive part held by Hungarians is, with a few exceptions, in the hands of unskilled laymen who accepted these jobs for no high cause but strictly on a business

Complete Details on Past and Present Ties to French Intelligence Services:

Part of the French Intelligence Service I had contact or these discussions with (Major) BUSTOP and (Major) LEBER and several times with Captain DEBET. The only time intelligence was mentioned during those discussions was when I told them that I am not working in the line of "Intelligence". The reason for meeting Captain DEBET on several occasions was because he was the supervisor of the Mandarin Guard Company set up by the French in Hanoi and I had to see him several times concerning the treatment, supply, administration, etc., of this company.

I intentionally stayed away from the N.B.B.K.'s intelligence work from the start. (See the report in Point 510.) Memorandum with Names Yugoslav Partisans at End of  
World War II

Originally General Istvan VJSAGY was in connection with General Draga MIHAILOVIC, head of the Yugoslav National Partisans, through the Hungarian liaison staff in Belgrade. (Formerly they both served in France as Military Attaches.) After General VJSAGY was arrested in March 1944 by the Germans, I took over this connection. One 2nd Lt. (Res. Corps), Iscol: Dr. HORY remained as officer advisor. (Present address: Innsbruck Compagnons 56.) Periodically we exchanged through him situation reports and sent material help to Draga MIHAILOVIC as far as it was possible. (Ammunition, medical equipment, office supply, etc.) This was the only possibility for me to stay in contact with the Western Powers Military Operational intentions concerning Hungary since according to HORY's reports also American and British officers served with the staff of Draga MIHAILOVIC. The last situation report from Draga MIHAILOVIC was forwarded through HORY in early October 1944 and had about the following contents: "The Westerns want to prevent the outbreak of differences with the Soviets through an open fight of my "Cetniks" with the Tito Partisans. Therefore they ordered me to withdraw my troops to Dalmacia. But it is not an Anglo-American interest that the Soviets gain territory. Therefore the Hungarian patriots should resist as long as possible and if they could be pushed out of Hungary you should find connection to me".

Report on Meeting with ZAKO Group

I am the organizer and spiritual leader of the Open  
EMER movement on ZAKO's request. I have done that with  
the idea that if the time comes the Hungarian emigrants  
would be morally and spiritually ready and united for  
guerrillas to assist the lone professional leaders in  
the Western Europe military fight against the Bolsheviks.  
I believed that the only way we could verify this goal  
would be if the movement remains non-personal for the  
public and safeguards its independence internally and  
externally up until an anti-Bolshevik alliance is formed  
in which also a small Hungarian Military Group could be  
represented. Therefore the above was one of my conditions  
to ZAKO. Because of different information and ZAKO's  
leading orientations I started to suspect more and more  
that ZAKO did not stick to the primary conditions which  
I advocated to the public. Therefore it was very doubt-  
ful whether the Western Europe and especially the U.S.A.  
could recognize the EMER under his leadership as a  
politically independent military resource. I did not  
have any facts to support my suspicion and such was  
almost impossible to obtain due to the confidential  
nature of the deal involved. Finally in November 1951  
I had received from Oliver LOVASS, at that time Chief of  
the EMER's French Intelligence Group, such information and  
facts that I had no more doubts that ZAKO was practically  
a "French Intelligence Agent"; for this reason the EMER  
under his leadership can not be regarded by those who  
know the everything stands as a politically independent  
Hungarian movement. Because of the foreign policy involved  
in this deal, I was unable to bring it up in the open for  
the members of the EMER and decided to bring up my  
conclusions on a closed meeting to the followers of ZAKO  
(Intelligence Group) and attempt to convince them about  
the impossibility to have ZAKO as a leader any longer.

It is a pity that I failed. LOVASK has been dismissed by the French, probably for his indiscretion. The Investigation Board of the MNRK did not find anything derogatory about ZAKO's person but was at the same time unable to convince us about ZAKO not having broken our agreement. I did not want to dig any further into this deal in order to avoid to disturb the Hungarian-French relations and to save the Hungarian masses faith for the MNRK. For this reason I decided to close the entire deal but at the same time I did not wish to have any further responsibility for such a leadership which, I am convinced, is going on a wrong way. I excused myself with ZAKO for having offended his personal honor but at the same time I resigned all my positions held with the MNRK Staff and also wanted to find a job somewhere else. In order to avoid destruction I agreed that my resignation should be published just as I would have received a job with the MNRK in a different position."

Current Status, Current Contacts:

"For the looks I did not break with ZAKO and his personal followers in a hostile way but I broke all remaining connections to the MNRK leadership and I do not intend to build up such connections again".

Specific Details on Background of ZORPOTAY's Leaving ZAKO Group:

"ZAKO is a violent, power-hungry and despotic personality whose mental abilities are not on the same level with his exaggerated ambitions. Therefore he likes to depend on co-workers with good ideas who have his trust as long as they satisfy his vanity and make him believe that they come without any conditions his distasteful ambitions. This way ZAKO's number one confident is always selected out of those intelligent young men

Opinion on Ferenc Szabadosz Mogaalon:

"The main effort is to advertise that Ferenc Szabadosz FAREAS is the leader with the best abilities for the fight to free Hungary. It is a fact that Ferenc FAREAS name is well known at home and in emigrant circles. But his popularity is not based on such facts and statements which could truly prove his outstanding abilities in front of all the Hungarians or even in front of a majority. I, for instance, consider the role he played in interior affairs at Altosttingen and his ties to the AFN in foreign policy for such mistakes which were dictated not by the wisdom of a leader but only by personal ambitions. Besides these facts there are spiritually and morally capable persons in his surroundings".

Opinion on Arpad HENNY's Hungarista Groups:

"A minority which is used to make sacrifices but without capable leaders. Neither has Arpad HENNY nor have the members of his ideological staff such conviction and generosity that they could utilize, instead of selfish struggles the "Hungarista" willingness for making sacrifices in the interest of the entire nation".

Opinion on "Union":

Opinion on Magyar Esotericism:

"A small, secret group of recklessly ambitious politicians who act illegally and advocate impracticable goals in the interest of their personal ambitions. It is not moral if someone does not want to prove his rights for political leadership through ability recognized by the public but only through confidential investigation of racial-descent. A leadership cannot be considered realistic if the leaders are holding their positions not because of their intellectual and moral capacities proved by their actions but only because of the possession of a doubtful sheet of paper concerning their descent".

Opinion on the Components of the Coalition Backing the Hungarian National Council in New York-Washington:

"The Hungarian Nation had in the near past (1919 and 1944), due to its geographical location, twice the occasion to select those intellectual leaders who considered the Soviet Bolshevism as an absolute enemy of the nation from those who did not. On both occasions those proved to be right who considered the Soviet Bolshevism to be an absolute enemy for the future interest of our nation and also acted according to this. Therefore, if the near future would bring a fight of life and death against the Soviet Bolshevism and the nation had to be called to arms, it is obvious that this could be carried out in a more convincing way by those who fought Bolshevism, consequently without seeking personal advantages. On the other side, those Hungarians at home and abroad who would sacrifice their lives in this fight would naturally rather be led by the above-mentioned persons than

contact with the U.S. Forces in Austria prior to his immigration to Canada in an attempt to clarify his break with ZAKO. Also enclosed in the envelope was a letter from KOPONAY addressed to CIC Salzburg. It was requested of NADAS to forward the letter to CIC and attempt to obtain an answer to the letter. (Agent's Note: A photostatic copy of a portion of KOPONAY's letter to SUBJECT is attached to the original and file copy of this report as Exhibit "II". The original letter is attached to the file copy.) The following is an English translation of the above-mentioned letter, Exhibit "II", translated from the Hungarian language by Informant 3702:

"The deal is more difficult and delicate concerning Points #3 and #4. Not that I feel guilty about the accusations mentioned in these points but because of the proof of the untruthfulness of them.

The true facts are as follows:

Point #3: I have been in Salzburg twice in 1950. First time on 11 January when I was on my way back from His Excellency SOOS (letter from HORTUJ and L.T.) and the second time on 1 June when I was together with you Colonel in the BAROZI deal. On none of those occasions did I meet R. or any other CIC representative.

I was called on 3 December 1950 by Hugo TRUX to Zell am See where he was on a CIC mission and inquired about one Emil MINOULAY III, and one Max NEUX, both of them Czech nationals. He also inquired about a Czech resistance movement called "SVETLANA". At this short meeting our wives and TRUX's children were also present. There was nothing mentioned concerning the B.K. Therefore it is not true that I was in Salzburg in the autumn of 1950. It is not true that I had any closer connections to R. It is not true that I had disclosed any information

concerning the B.K. and it is especially untrue that I handed over copies of confidential documents. Finally, it is absolutely untrue that I ever received any compensation for this non-existing "work" of mine.

Points #5 and #7 are also impertinent lies and indicate how low certain persons can become.

To Point #4 I herewith quote extracts of my diary:

21 March 1951 Salzburg. Lunch with GOGO. He is excited, so is Gyurka. Together with HEGEDUS, Pista's wife, TAUBINOR Pista's book "JERSEY MIRADO" and plans for a printing shop. A lot of arrests at home because of pamphlets and the smuggling in of the Hungaria. This is not done for the goal but for advertisement what we criticized about the BVAOS.

22 March 1951 The Diemel - train is not running, I visit the Hungarian Office. There is a large crowd. BARANKOVICS criticizes KORNHARTZ's entering, this is politics. HAGY Mihaly: HURGET has forbidden the group leaders to act as correspondents. HAMVAS resigns his job with the Office. W. has arrived from Germany. Hilde and sister are visiting. Albin left for London  
(According to these I spent the first day with Gyurka (I have resigned on the 15 III.) next morning until noon I had been at the Hungarian Office where I informed HAMVAS that unwillingly I had have to emigrate. In the afternoon I had visitors at my home already. Therefore

... a resistance movement whereby the intelligence part could be covered by already existing organizations. They agreed to my plans concerning propaganda and the exterior set-up. I was asked to forward a more detailed plan.

"I disclose my plans, they believe that it is of too large a scale, we have to start on a very small scale. There has been no decision yet, they want to employ me as an agent for four months. It is hopeless. I intend to agree but really I am very disappointed."

(According to this the entire deal was turned down somewhere for unknown reasons or it was postponed to a later date until certain points could be cleared and until the final decision they wanted to employ me in positive intelligence.)

I definitely decided to emigrate and started to expedite my preparations in this direction.

Call on Sea. HARDY and WALKER arrived. Washington agreed to my person but they want to start on a very small basis. I make them understand my position. (Unfavorable resistance movement - BRITAIN, Korea - my personal - co-workers - Migration - Free Europe) They have to depart in.

to go friendly apart and I receive \$10 and a portion of cigarettes. They do not advise me to migrate to the U.S.A.

I was under the impression that they were sorry about the break-off of our connection. This was also indicated by the fact that they informed me that in such questions they were only small executive persons.

- a./ The Americans are not our enemies and one not only

During the first meeting they showed me a register where my name was mentioned on the 9th page and it was also known that I lately worked in the Information Service of the B.R.

It is not true that I mentioned the near dissolution of the B.R. But without going into details I mentioned the grave differences within the B.R., and that I was not the only one who was of this opinion in the staff. I also mentioned that there is no organized military resistance in Hungary and that the KOPJAI movement which they intended to re-activate diminished with time. In addition to this I mentioned that the B.R. has no independent intelligence and that because of the B.R. leaders' personal participation in intelligence work, this planned central intelligence register also failed. Finally, I stated that no one of the B.R. intelligence staff members has any intelligence background, etc.

All these statements I have made not only because they were true but also because I had the feeling that I was dealing with representatives of an important organization whereby I could have only harmed if I would have been bluffing. I do not doubt that all that I have stated has changed the picture they have received of a former meeting with General X. But this was not my fault because I did not know of such a meeting nor did I know of what had been discussed at this meeting.

It is not true that I have received 2,000 German Marks. It is possible that the entire expense, including the expenses of their representatives amounted to this sum but this is not of the B.R. business. I delayed my migration from one month to the other because of these difficulties and it is just natural that they scoured my living until a final decision. Speaking of the financial situation it was characteristic that at the Zell on 1st meeting on 5 July I notified them that I was unable to accept the job under the present circumstances and offered them to reimburse the \$160 I received after I emigrated. Thereupon, they not only refused it but gave me \$40 plus a carton of cigarettes.

It is not true that I was turned down. I was the one who refused their offer and in addition to this I made my proposition not for my person but for the cause. Therefore, for instance, I did not even mention my name in my second memorandum's personal roster due to my illness. This is simply the true situation.

It is possible that you, colonel, know more of it but I have to assume everything.

I was convinced that they wanted to do something seriously. The memorandum went all the way up to Washington and was turned down somewhere along the road. This somewhere could have been in the states but also could have been with Eisenhower's Staff, or it could have been turned down because of different U.S. interests; one of them might have been against one or the other for Z. It is possible that Z. found out of it from the Americans but I much rather think that he did find out from the French. The latter one would be indicated more by Point 3 and Point 4 which are untrue and confused. The fact is that a confidential discussion carried with a secret U.S. organization not only leaked but came out in wide publicity (Staff meeting, ABAY's letter, investigations). They also threatened me to publish it in the press in which case I would also be forced to come out in the open which would have undesirable consequences.

There is no doubt in my mind that such a small fight in the press could grow to quite a scandal in the presidential year and in times of investigations. On the other side, I am not willing to take everything; I have had enough in the past.

During my discussions with the Americans and with my memorandums I never crossed the Hungarian Military duties nor have I done anything immoral. Therefore, I wish to clear these accusations. Especially because I always looked at the B.K. as the unsworn Hungarian Emigrant Army and not as Z.'s financed organization.

I do not know the B.K.'s present position, nor do I know its present connections with the Americans. I was also not informed about your position after the investigation.

Therefore, I can write only what I generally believe. I think that this deal cannot be touched without causing a scandal. All four of the gentlemen with whom I had discussions behaved like real gentlemen up to the end. I feel obliged to them to let them know the entire deal before I undertake any steps. (Attached letter written to them.) If they also believe that I am a "gamester" then I will have to find other means.

I believe that the entire deal could be solved the easiest way if CIC Salzburg would give a written or verbal statement in front of witnesses according to which:

- a./ S. had no connection with CIC in 1950 and did not receive any financial support.
- b./ The organization is not aware of any facts which would be derogatory concerning case Hungarian military or general human honor.

This way the "truth" would be proved and it could be avoided that the deal would be brought to Council. That much I believe could be pressed out of them.

There is no doubt that further up someone will receive a kick for this. But there is more to this deal than to worry about the kick one of 2.'s protectors will receive or not.

EASTON, TRUX or, indirectly, one of the four gentlemen can certainly still be located.

Please excuse me for bothering you with my letter but I have to write you for the following reason.

The interior staff of the MHBK gravely accused me in its memorandum taken at a meeting on 23 February 1952. These accusations were forwarded to me with the remark that if I would criticize in the future the B.K. leadership or the leader I would be dismissed from the MHBK and the entire reason of my dismissal would be published in the paper "Hadak Utja".

Their findings in Points 13 and 14 are as follows:

3./ Miklos KORPONAY Gen. Staff Captain came in close contact in the fall of 1950 with Mr. R. (RINGER) at CIC Salzburg and agreed to furnish confidential information to him concerning the MHBK. During this activity he furnished false or generally derogatory information concerning the MHBK staff and its activity. He also furnished copies of confidential documents and received for this work a high monthly salary.

4./ From 18 June 1951 to 20 June 1951 Miklos KORPONAY had discussions with Americans concerning intelligence work. According to information received from proper U.S. Authorities on a later date, after Captain Miklos KORPONAY's emigration, it was found that he contacted the Americans during above date and not only acted as an ex-MHBK member but also as the chief of the MHBK Intelligence. According to statements of Americans (e.g. Mr. C.) KORPONAY's information concerning the dissolution of the MHBK confused them entirely and changed the picture

I do not know and I am not interested in the reasons why our confidential discussions came out in the open. This has happened and probably had to be done for some higher interest. But this fact and especially the threats of the MIBK Staff that they will bring my person in publicity could have undesirable consequences. I will always fight for my honor with all means and no one can blame me for that. Therefore, I intend to clear the above-mentioned accusations respectively the way they were brought up.

At the same time when I am ready to prove the truth I would like to avoid to compromise the faith put in the secrecy of an important U.S. organization through widespread correspondence, investigations and possible press campaigns. I feel that because of the way you treated me it is my duty to notify you and ask you for your opinion and advice before I would undertake any steps to clear above-mentioned points. Since I am unable to appear personally please discuss all the possibilities and details over with Lajos RADAS, General Staff Colonel.

Please excuse me again for bothering you and causing you all this trouble against my will. But the truth and honest intention should prevail, not even in the most unimportant things. In this belief I request your soon notification.

AMIRAL, Headquarters European Command (Intelligence Division), (dated 1 December 1950 (Ref. No. 350.09 (GID/ops/0011)) lists one Major NADAC, born 4 March 1902, as an informant who was dropped on 5 October 1950 by an Intelligence Agency in the U.S. Zone of Germany or Austria for "ineptitude".

Miklos KORPONAI is mentioned in numerous reports in the files of this Sub-Detachment as a former Hungarian Army Captain who is a leading member of the MIUK in the French Zone of Austria and the organizer of Hungarian refugees to fight in case of a future war with the present Communist regime in Hungary.

AGIST REPORT, CIC, Sub-Detachment "B", dated 5 December 1949, (Ref. No. L/17002), Subject "Austria - Alleged Soviet Agents Working with French Intelligence", lists one Miklos KORPONAI as a Hungarian resident of Innsbruck who, under the pretext of keeping refugees who have fled Hungary for political reasons, is able to compile valuable lists for the Soviets. Through advance notice from KORPONAI many Hungarian refugees have been arrested in Vienna.

Dr. Friedrich PIKLY-SCHNITZ is described in numerous reports in the files of this Sub-Detachment as a member of the Hungarian Socialist Party who was sent to Vienna by Dr. Karl PEYER, a Hungarian Socialist leader, to "feel out" whether or not the PEYER Group could obtain backing from the Austrian Socialist Party and who later fled from Hungary and received asylum in the U.S. Zone of Austria as a political refugee. In October 1948, during a meeting in Paris of the Right-Wing Hungarian Social Democratic Party in exile, he was elected the Secretary-General under the Group's leader, Oskolas PEYER.

Jozsef HARTAS is mentioned in the files of this Sub-Detachment as a Hungarian refugee residing in Salzburg, who is a former member of the Hungarian Restitution Mission in Vienna and who is currently employed with the USPA Air Section in Salzburg.

REPORT FROM, CIC, Sub-Detachment "A", dated 15 December 1949 (Ref. No. S-6149), Subject: "IVANYI Ladislous, FIB Operative", mentions one Erwin ~~ARON~~ as a French Intelligence Service Operative residing at Intel J, Bad Hall.

The files of this Sub-Detachment contain voluminous information concerning one Geza NAGY, believed to be identical to personality mentioned above, as a person who was responsible in setting up a Hungarian Intelligence Agency in the U.S. and British Zones of Austria.

The files of this Sub-Detachment mention one Albin ~~ERNEST~~ Albin ~~ERNEST~~, (born 16 May 1908), a Hungarian residing at Kuapendee/see, Koschatweg 59 as an Informant dropped on 20 September 1949 by a U.S. Intelligence Agency in the U.S. Zone of Austria or Germany for "compromise".

Ferenc ~~ARON~~, mentioned above, is described in numerous reports in this Sub-Detachment as a former Hungarian Army General currently residing in Munich, Germany, where he is very active in the organization of Hungarian refugees.
