1. [ ] AND [ ] HAD MEETING MORNING 15 NOVEMBER WITH ALIASES ACKERMANN AND KRUG RE VISIT TO BKCROWN HQS. [ ] EXTENDED FORMAL INVITATION ON BEHALF BKCROWN. ACKERMANN EVIDENTLY PLEASED ABOUT TRIP AND LOOKING FORWARD TO SUBSTANTIVE DISCUSSIONS VARIETY OF MATTERS, INCLUDING THOSE LISTED BELOW. WE REQUESTED ACKERMANN TO REVIEW AGENDA PREVIOUSLY PROPOSED BY ALIAS FLEMING TO CLARIFY WHICH TOPICS ALSO OF INTEREST TO HIM AND TO ADD ANYTHING ELSE HE PROPOSES TO DISCUSS. HE PROMISED REPLY AT NEXT MEETING WITH BKCROWN 20 NOVEMBER WHEN HE WILL ALSO BE ABLE TO PROVIDE EXACT INFO ABOUT TRAVEL TIMES.

3. ONLY SPECIFIC SIGHT-SEEING WISH EXPRESSED BY ACKERMANN WAS DESIRE TO VISIT NATIONAL GALLERY. KRUG WANTS TO VISIT KENNEDY GRAVE.

4. AMONG TOPICS ACKERMANN SUGGESTED HE WOULD LIKE TO DISCUSS ARE FOLLOWING. ADDITIONAL SUGGESTIONS MAY FOLLOW AFTER 20 NOVEMBER MEETING:

A. GENERAL VIEWS ON SOVIET SERVICES. ACKERMANN RECENTLY READ BKCROWN STUDY "STYLE OF AEKICK OFFICERS" AND FOUND IT VERY STIMULATING. HE WOULD WELCOME ADDITIONAL GENERAL INSIGHT OF THIS NATURE.

B. VIEWS ON OPERATIONAL POLICY, SPECIFICALLY, WHETHER GASCOPE SHOULD CONCENTRATE ITS RESOURCES ON RELATIVELY SMALL NUMBER OF RELATIVELY HIGH-LEVEL TARGETS AND OFFER LARGE SUMS FOR DEFECTION (ACKERMANN TALKED IN TERMS OF ONE MILLION MARKS FOR A SOVIET MILITARY ATTACHED), RATHER THAN SPEND SIMILAR AMOUNT IN SMALL SUMS FOR RELATIVELY LARGE NUMBER OF LOW-LEVEL AGENTS AS AT PRESENT. ACKERMANN WOULD LIKE TO HEAR BKCROWN VIEWS AND EXPERIENCES IN THIS AREA. HE IS OBVIOUSLY VERY IMPRESSED WITH VALUE OF DEFECTOR, SUCH AS DS3071.

C. BKCROWN VIEWS AND EXPERIENCE ON PSYCHOLOGY OF RECRUITMENT, I.E. WHAT SHOULD BE LOOKED FOR IN TARGETS, AND WHAT SHOULD BE OFFERED OF THEM.

U D. ACKERMANN RAISED QUESTION WHETHER BKCROWN AND CASCOPE SHOULD NOT COORDINATE MORE CLOSELY THEIR ACTIVITIES IN THIRD-WORLD WHERE OUR INTERESTS ARE PARALLEL AND SHOULD NOT BE DUPLICATIVE. AS EXAMPLE, ACKERMANN SAID CERTAIN AFRICAN COUNTRIES MIGHT APPROACH CASCOPE (NOT FRENCH BECAUSE WERE FORMER COLONY AND NOT UNITED STATES BECAUSE OF FEAR OF IMPERIALISM) WITH REQUEST FOR SUPPORT IN EQUIPPING AND GUIDING SECURITY SERVICE. CASCOPE NOT ALWAYS SURE WHAT IS TO WESTERN INTEL ADVANTAGE AND ACKERMANN SUGGESTS PERHAPS THERE SHOULD BE AREA OF COORDINATION HERE FOR MUTUAL GOALS. ACKERMANN SPECIFICALLY INCLUDED ASIA, AFRICA, AND LATIN AMERICA IN THIS CONTEXT. [ ] SUGGESTED THIS TOPIC MIGHT BE TOO LARGE FOR THIS VISIT, DEPENDING ON REST OF AGENDA, AND DEPENDING ON WHO BKCROWN DISCUSSION PARTNERS WOULD BE, AND HE AGREED THIS MIGHT BE TOPIC FOR FUTURE DISCUSSION.

5. [ ] ALERTED ACKERMANN TO BE PREPARED FOR BKCROWN OFFICERS TO RAISE SUBJECT OF TERRORISM. ACKERMANN SAID HE WOULD PREPARE HIS THOUGHTS ON THIS.

6. ALSO ALERTED ACKERMANN TO PROBLEM OF ARRANGING WHETHER OR NOT CASCOPE WASH REP ALIAS HARTWIG SHOULD ATTEND ALL DISCUSSIONS.
