1. APPRECIATE REF WHICH USEFUL NOT ONLY IN CLARIFYING YOUR HANDLING OF PAST REQUESTS BUT ALSO IN THE WORTHWHILE SUGGESTIONS IN PARA 4.

2. AS A GENERAL GUIDELINE IN HANDLING FUTURE REPORTS RECEIVED BY STATION FROM LIAISON PLEASE SEND THEM TO HQS FOR FORMAL PASSAGE TO LNERGO HQS EVFN IF THE ORIGINAL REQUEST TO LIAISON FOR THE INFO WAS FROM LNERGO. ANY PASSAGE LOCALLY SHOULD BE WITH CAVEAT THAT RVROCK HQS DISSEMINATING AND THAT LOCAL PASSAGE IS FOR INFO LNERGO REP ONLY.

3. RE PARA 4 A REF, WE HAVE TRIED IN PAST WITHOUT SUCCESS TO GET AN AGREEMENT WITH LNERGO HQS SIMILAR TO THAT SUGGESTED IN REF. LNERGO HAS ALWAYS BACKED OFF FROM A FINAL DECISIVE CONFRONTATION. AS A RESULT WE ARE NOW PROCEEDING ON

 EARLIER THIA MONTH REQUESTED MAXIMUM EXPLOITATION ALL
 EXISTING SOURCES FOR COVERAGE MHCHAOS TARGET AND DEVELOPMENT
