1. FOLLOWING IS FOR GUIDANCE TO STATIONS WHERE AN LNERGO REP IS ASSIGNED. IT GIVES CURRENT STATUS OF HQS ARRANGEMENTS WITH LNERGO ON COVERAGE OF MHCHAOS MATTERS WITH FOREIGN LIAISON SERVICES. HQS HAS BEEN WORKING WITH LNERGO LIAISON OFFICER FOR MONTHS IN ORDER TO ARRIVE AT PROCEDURES WHICH WILL PERMIT MOST EFFECTIVE AND SECURE HANDLING IN THE FIELD WHILE AT SAME TIME ENSURE THAT JKLANCE'S RESPONSIBILITIES FOR COVERAGE OF THIS TARGET ABROAD ARE FULLY PROTECTED.

2. JKLANCE IS HELD RESPONSIBLE BY WHITE HOUSE FOR ALL FOREIGN COVERAGE OF MHCHAOS MATTERS AND MUST THEREFORE

RETAIN COMPLETE FREEDOM OF ACTION TO COLLECT FROM FOREIGN LIAISON SERVICES AND TO DISSEMINATE ANY INFORMATION SO ACQUIRED AT JKLANCE'S DISCRETION. IN PRACTICAL TERMS, THIS MEANS THAT WE CANNOT ABDICATE TO LNERGO REPS ABROAD BY GIVING THEM EXCLUSIVE RESPONSIBILITY FOR HANDLING MHCHAOS REQUIREMENTS WITH LIAISON, EITHER IN CRASH SITUATIONS OR ON "ROUTINE TRACES."

B. YOU MAY INFORM LNERGO REP THAT:

- 1) ON INSTRUCTIONS FROM YOUR HQS YOU ARE PROCEEDING TO DISCUSS REF MATTERS WITH FOREIGN SERVICES. FOREIGN SERVICES
- 2) YOU WILL ASK / TO PROVIDE JKLANCE INFORMATION CONCERNING THESE MATTERS.

- 3) JKLANCE HQS WILL PASS TO LNERGO HQS ANY PERTINENT INFO RECEIVED FROM FOREIGN SERVICES.

4. THE ABOVE POLICY STILL STANDS AND SUBSEQUENT DISCUSSIONS WITH LNERGO HAVE BEEN DESIGNED TO RESOLVE SPECIFIC PROBLEMS OF

A) COORDINATING ACTION WITH LIAISON WHERE THERE IS AN LNERGO REPRESENTATIVE, AND B) ELIMINATING INSECURE AND DUPLICATING LNERGO TRACES WITH LIAISON WHERE NO LNERGO REP IS STATIONED. (THERE

HAVE BEEN INSTANCES OF LNERGO REPS CONTACTING LIAISON SERVICES OR CHIEFS OF STATIONS IN OTHER COUNTRIES BY PHONE.) THESE DISCUSSIONS HAVE BEEN CONFINED TO SITUATIONS WHERE A TARGET OF HIGH INTEREST TO LNERGO IS TRAVELING ABROAD AND LNERGO HAS ASKED FOR JKLANCE ASSISTANCE IN COVERAGE.

5. AS A RESULT OF JKLANCE PRESSURE, LNERGO HQS HAS AGREED THAT IF TRAVELLER'S ROUTE IS KNOWN OR BELIEVED TO INCLUDE BOTH COUNTRIES WITH AND COUNTRIES WITHOUT AN LNERGO REP:

A. JKLANCE WILL HANDLE COVERAGE WITH LIAISON IN ALL COUNTRIES INCLUDING THOSE IN WHICH A LNERGO REP IS STATIONED. LNERGO REP IN ANY SUCH COUNTRY (S) WILL BE INFORMED OF THESE CASES BUT TOLD TO TAKE NO ACTION.

B. IN ADDITION TO FORWARDING IT TO HQS, COS MAY PASS INFO RECEIVED FROM LIAISON TO LNERGO REP WHO IS FREE TO FORWARD SUCH INFORMATION TO HIS HQS BUT WITH THE PROVISIO THAT IT IS NOT TO BE FURTHER

DISSEMINATED BY LNERGO HQS.

6. PROBLEM OF A TRAVELLER KNOWN OR BELIEVED TO BE VISITING ONLY A COUNTRY OR COUNTRIES WHERE THERE IS/ARE LNERGO REPS IS STILL NOT SETTLED. LNERGO DESIRES TO USE ITS REP TO DEAL WITH LIAISON ON SUCH CASES. FOR REASONS CITED PARAS 2 AND 3 ABOVE, JKLANCE CANNOT AND DOES NOT ACCEPT THIS. AS PRACTICAL MATTER, IT PROBABLY MEANS THAT FOR TIME BEING LNERGO NORMALLY WILL NOT INFORM US OF SUCH TRAVEL UNTIL AFTER IT HAS TAKEN ACTION. MEANWHILE PLEASE BE ASSURED THAT IN ANY SUCH CASES WHICH MAY ARISE WE WILL TAKE INTO FULL CONSIDERATION AND PROTECT THE OVERALL JKLANCE EQUITIES WITH FOREIGN LIAISON.

7. FYI: FOLLOWING PROCEDURES ARE FOLLOWED AT HQS PRIOR INITIATING LIAISON TRACES ON PERSONS OF MHCHAOS INTEREST IDENTIFIED IN LNERGO REPORTING. HQS FIRST QUERIES LNERGO TO DETERMINE IF LNERGO REP ABROAD HAS ALREADY TRACED SUBJECT WITH FOREIGN LIAISON. IF SO, HQS REQUESTS RESULTS FROM LNERGO HQS. JKLANCE FIELD STATION ACTION IS REQUESTED ONLY IN CASES IN WHICH LNERGO
