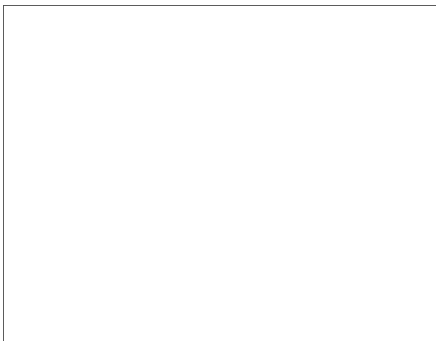

TEXT: 1. FOLLOWING THE ORDER OF FORMER ZAIRIAN PRESIDENT
((MOBUTU)) SESE SEKO THAT ONLY 11 PERSONS, INCLUDING HIS SON,
KONGOLO, BE PERMITTED TO DISEMBARK FROM THE CONGOLESE AIRLINER IN
LOME, TOGO, THE 74 PERSONS REMAINING ABOARD DEPARTED THE EVENING

OF 20 MAY FROM LOME AND TRAVELED TO CHAD WHERE THEY REMAIN. THE AGREEMENT, APPARENTLY REACHED WITH CHADIAN AUTHORITIES, IS THAT THE PLANE COULD LAND IN NDJAMENA FOR FUEL AND A BRIEF STOPOVER BUT WOULD THEN BE EXPECTED TO CONTINUE ON TO AN AS YET UNKNOWN DESTINATION.

2. [REDACTED] MOBUTU REMAINS IN LOME AND HAS NOT CONTINUED TO TRAVELED TO MOROCCO BECAUSE HE IS TOO SICK (NFI) TO FLY THE NEXT LEG OF THE TRIP. [REDACTED] COMMENT: DETAILS ARE NOT AVAILABLE, HOWEVER, THE IMPRESSION BEING GIVEN IS THAT THE FORMER PRESIDENT'S MEDICAL CONDITION IS "SERIOUS."

[REDACTED] MOBUTU'S SPECIAL ADVISOR FOR NATIONAL SECURITY AFFAIRS, HONORE ((NGBANDA)) NZAMBOKO ATUMBA, THE FORMER PRESIDENT'S CHIEF OF STAFF, FELIX ((VUNDUAWA)) TE PEMAKO, AND MOBUTU'S BROTHER-IN-LAW, GENERAL ((BARAMOTO)) KAMA KPATA ARE IN SOUTH AFRICA. FORMER PRIME MINISTER GENERAL ((LIKULIA)) BOLONGO IS BELIEVED TO BE IN LOME WITH MOBUTU.

4. ON 26 MAY, NGBANDA PLANS TO TRAVEL FROM SOUTH AFRICA TO BRAZZAVILLE, CONGO, WHERE HE INTENDS TO "TAKE CARE OF" THE PROBLEM OF THE ZAIRIAN AIRCRAFT, BELONGING TO FORMER PRESIDENT MOBUTU, WHICH IS LOCATED ON THE TARMAC AT MAYA MAYA AIRPORT. [REDACTED]

COMMENT: ALLIANCE AUTHORITIES IN KINSHASA HAVE BEEN PRESSURING THE GOVERNMENT OF THE CONGO (GOTC) TO IMMEDIATELY TURN OVER THE AIRCRAFT TO THE NEW GOVERNMENT IN KINSHASA. TO DATE, THE GOTC HAS NOT TAKEN ANY ACTION ON THE MATTER DESPITE APPARENTLY INCREASING THREATS (NFI) BY THE NEW REGIME.) AFTER 24 HOURS IN BRAZZAVILLE, NGBANDA PLANS TO TRAVEL TO LOME TO MEET WITH MOBUTU. [REDACTED]

COMMENT: NGBANDA STILL ACTS AS THOUGH HE IS TAKING CARE OF MATTERS FOR THE ZAIRIAN PRESIDENT AS THOUGH MOBUTU WERE, IN FACT, THE CHIEF OF STATE. THERE SEEMS TO BE A LACK OF ACKNOWLEDGEMENT ON THE PART OF SOME PARTIES OF THE REALITY OF THE SITUATION; I.E., THAT THEY NO LONGER HAVE THE SAME PRIVILEGES AND PROTECTION AS A WEEK AGO.)
