THERE ARE POSSIBLY NO TWO MEN ALIVE IN AMERICA AS MUCH INJURY TO MY LIFE THE PAST FEW YEARS AS ROBER ALLEN DULLES, YET, RECALLING A TIME WHEN I HELD YOU BOX ALMIRATION, I LOOK TO THOSE DAYS, FROM WHICH I FEEL COOR NT CH ENADED TT I THE FOLLOWING INFORMATION TO YOUR ATTENTION.

During the past 8 days I have tried to back-track my life in the most recent years and in various cities where I might have known this man or those to whom he was associated, If my memory serves me right Jack Ruby was visiting Syndicate members in San Diego between the last months of 1961 and early months of The meeting of the Syndicate Members was at "The Brass Rail, a bar-resturant owned by two Hungarian members. It is used as a homosexual bar, much as the New York Syndicate under the former Gallo gang used some dozen homosexual bars as"fronts Today the Synthesis in New York and Chicago are using Stoti Dance bars, as the ease bars, harem dancing bars, and the hot-dog houses as "fronts,"

4. Jack Room is known as a "finger-man" in these derations not on Vis it probable for him to have had a head in (a) the application of President Kennedy by Oshald, but IVA Rightarranged the attitudes for the assissination which was ord ordered the actual killing of President Kennedy.
