TEXT OF REPORT BY RADIO AUSTRALIA ON 7 APRIL

THE LAWYER FOR DAVID HICKS, THE AUSTRALIAN ACCUSED OF BEING A TALEBAN FIGHTER, HAS EXPRESSED MORE FRUSTRATION OVER WHAT HE CALLS THE FEDERAL GOVERNMENT'S INACTION REGARDING HIM. THE US GOVERNMENT HAS AGREED TO PERMIT AUSTRALIAN OFFICIALS TO TRAVEL TO CUBA TO INTERVIEW HICKS, WHO HAS BEEN HELD BY US FORCES IN THE GUANTANAMO BAY HIGH-SECURITY FACILITY SINCE HIS CAPTURE LATE LAST YEAR. THE FOREIGN MINISTER, ALEXANDER DOWNER, SAYS AUSTRALIAN OFFICIALS MET HICKS WHEN HE WAS FIRST CAPTURED IN AFGHANISTAN AND ANOTHER MEETING IS IMMINENT. HE SAYS EVENTUALLY THE UNITED STATES WILL EITHER CHARGE HICKS OR RELEASE HIM TO AUSTRALIAN AUTHORITIES, BUT HICKS'S LAWYER, STEPHEN KENNY, SAYS THAT ATTITUDE FROM MR DOWNER IS NOT GOOD ENOUGH.

[KENNY] NO IT'S NOT, REALLY. I MEAN, ASIO [AUSTRALIAN SECURITY INTELLIGENCE ORGANIZATION] AND FEDERAL POLICE INTERVIEWED HIM ON 24 DECEMBER. I MEAN, IT IS NOW APRIL. HE HAS BEEN IN CUSTODY SINCE THAT TIME, IN A CAGE, WITHOUT CHARGE AND WITHOUT ANY DETERMINATION BEING MADE ON THE GROUNDS FOR HIS DETENTION. I DON'T THINK THAT IS GOOD ENOUGH.
