When Security's list indicated only the time, I checked the calendar sheets and added the name of the person indicated as having been with the DCI at that time. Each of these has asterisks (**) to indicate that I assume this to be the person recorded.

When Security's list gave the time but the calendar sheet was so unclear that I could not come up with the identity of the person with the DCI at that time, I put an asterisk (*) that I could not determine the identity.




