BACKGROUND:

1. A ^{RYROCK} ~~WCFIRM~~ EMPLOYEE LEARNED SOME INFORMATION FROM AN LNERGO SPECIAL AGENT WHICH HE PASSED ON TO A THIRD PARTY RELATED TO AN INSIGNIFICANT CASE. (^{RYROCK} ~~WCFIRM~~ WAS OFFICIALLY ADVISED THAT LNERGO WAS NOT INVESTIGATING THE CASE IN QUESTION.) THIS PROMPTED DIRECTOR OF LNERGO TO REQUEST IDENTITY OF THE SPECIAL AGENT. AS A POINT OF HONOR AND PERSONAL INTEGRITY, THE ^{RYROCK} ~~WCFIRM~~ EMPLOYEE REFUSED TO DIVULGE THE IDENTITY OF HIS SOURCE.

4. THIS ARBITRARY LNERGO RULING PLACES AN AWKWARD BURDEN ON HEADQUARTERS. AS WE NOW UNDERSTAND IT, THE OFFICIAL REPEAT OFFICIAL RELATIONS WHICH ARE MAINTAINED WITH LNERGO REPRESENTATIVES IN YOUR AREA SHOULD NOT BE AFFECTED. REASON REQUIRES THAT WE KEEP IN MIND THE POSSIBLE EROSION OF RELATIONS CAUSED BY RUMORS AND EXAGGERATIONS WHICH AN INCIDENT OF THIS NATURE ENGENDERS. ALL CONCERNED MUST HANDLE THEIR LIAISON WITH LNERGO REPRESENTATIVES IN A BUSINESS-LIKE MANNER AND WITH RECTITUDE. IT IS PROBABLE, IN TIME, THAT YOU WILL BE SUBJECTED TO THIRD-PARTY ~~WIER~~ INQUIRIES WHICH SHOULD BE TURNED ASIDE OR REFERRED TO HEADQUARTERS.

1. SINCE 24 FEBRUARY 1970 THIS AGENCY HAS NOT RECEIVED SUBJECT TELETYPE REPORTS FROM YOUR BUREAU. THESE REPORTS ARE OF VALUE TO THIS AGENCY IN FULFILLING ITS COUNTERINTELLIGENCE MISSION ABROAD AND IN PROTECTING THE SECURITY OF ITS INSTALLATIONS IN THE UNITED STATES.

2. I WOULD APPRECIATE BEING ADVISED IF THESE REPORTS ARE STILL BEING PREPARED BY YOUR BUREAU, AND, IF SO, IT IS REQUESTED THAT THIS AGENCY CONTINUE TO RECEIVE THEM ON A REGULAR BASIS.
