

Dear Mr. Schlesinger:

For purposes of our investigation, it is necessary to determine whether [redacted] applied for employment with the Central Intelligence Agency during the past ten years and, more specifically, whether he applied during the period November 1971 to July 1972. I would appreciate it if either you or someone on your staff could supply us with this information, and, if [redacted] has applied for employment, if we could examine his file and speak to those individuals who interviewed [redacted]. If Mr. [redacted] was in fact employed by the Agency, we would like to speak with those individuals who worked with him.

We may have similar requests in the future, and I would be happy to consider your suggestions as to the procedure for submitting such requests that you would consider most efficient. I look forward to hearing from you.
