These incidents did not result in the website bei unavailable, and each one was reported to both and IMS management. As a result of the attacks, a decision was made to apply several security patches to the website to ensure that we would not be vulnerab future attacks. Unfortunately, a new attack was launched, This occurred on June 19 believe at that time that the site was hit with a attack. Currently, the FOIA ERR website is completely unavailable.	(b)(3)
(S/NF) So far, we have attempted to restore the server to two different snapshots from June, with complete restarts of the server each time. Neither attempt was successful. Our next steps are to move farther back in time to May to see if we can restore to that point in time. We have been elevated to support with our server hosting company.
