(S//NF) Doug, [redacted] The CIA's public FOIA website has been successfully hacked, and the damage to the database is unknown. I received the note below from [redacted] the deputy branch chief who brought this to my attention.

(S//NF) Starting June 6, 2014, the FOIA Electronic Reading Room team was notified of several denial of service attacks on the public-facing reading room website. These incidents did not result in the website being unavailable, and each one was reported to both [redacted] and IMS management. As a result of the attacks, a decision was made to apply several security patches to the website to ensure that we would not be vulnerable to future attacks. Unfortunately, a new attack was launched, [redacted] This occurred on June 19 [redacted] We believe at that time that the site was hit with a [redacted] attack. Currently, the FOIA ERR website is completely unavailable.

(S//NF) So far, we have attempted to restore the server to two different snapshots from June, with complete restarts of the server each time. Neither attempt was successful. Our next steps are to move farther back in time to May to see if we can restore to that point in time. We have been elevated to [redacted] support with our server hosting company. At this time, we do not have an ETA on when the site will be restored.

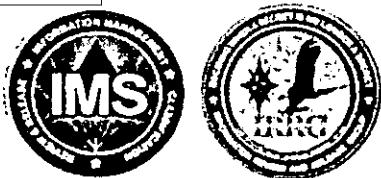
