COPIES MAY N SUMMARY: THE VENEZUELAN GOVERNMENT HAS ESTABLISHED A SPECIAL OFFICE IN THE MINISTRY OF INTERIOR TO HANDLE THE INVESTIGATION OF THE 1976 KIDNAPPING OF UNITED STATES BUSINESSMAN WILLIAM F. NIEHOUS. TON THIS GROUP IS BEING HEADED BY RAFAEL RIVAS VASQUEZ WHO IS TECHNICAL DEPUTY CHIEF OF THE DIRECTORATE FOR THE SERVICES OF INTELLIGENCE AND $\overline{\mathfrak{O}}$ POWER STRUGGES PREVENTION (DISIP). RIVAS, HOWEVER, IS IN THE MIDST OF A WITH HIS IMMEDIATE SUPERVISOR, RETIRED GENERAL RAUL GIMENEZ GAINZA, THE DIRECTOR OF DISIP. GIMENEZ, WHO FULLY EXPECTS RIVAS TO FAIL, THUS ENDING HIS CAREER, IS INDEPENDENTLY PURSUING THE CASE IN THE EASTERN STATES OF VENEZUELA, BOTH THROUGH DISIP PEOPLE UNDER HIS COMMAND AND AN EXTRA-OFFICIAL SECURITY UNIT OPERATING IN THE AREA. - 2. ACTING ON RECENTLY RECEIVED INFORMATION INDICATING THAT KIDNAPPED UNITED STATES BUSINESSMAN MILLIAM F. NIEHOUS WAS ALIVE AS DE MARCH 1977, THE VENEZUELA'S GOVERNMENT IS STEPPING UP ITS INVESTIGATION OF THE CASE. TO CARRY THIS FORWARD, A SPECIAL OFFICE IN THE MINISTRY OF INTERIOR HAS BEEN ESTABLISHED TO ACT AS THE FOCAL POINT FOR THE INVESTIGATION. THIS OFFICE IS HEADED BY RAFAEL R I V A S VASQUEZ, DEPUTY CHIEF OF THE DIRECTORATE FOR THE SERVICES OF INTELLIGENCE AND PREVENTION (DISIP), AND WILL CALL UPON DISIP, THE DIRECTORATE OF NILITARY INTELLIGENCE (DIM), AND THE TECHNICAL JUDICIAL POLICE (PTJ) FOR SUPPORT.
- 3. THE NIEHOUS INVESTIGATIVE GROUP WILL HAVE A STAFF OF SIX

 DISIP OFFICERS AND 12 UNDERCOVER AGENTS ARE TO BE ASSIGNED TO THE

 CASE AS INVESTIGATORS AND SURVEILLANTS. ADDITIONAL MEN WILL BE

 ASSIGNED TO THE GROUP ON AN AD HOC RASIS. THE GROUP IS EXPECTED

 TO HAVE AN OPERATING BUDGET OF BS. 85,000 (U.S. \$19,860) PER MONTH.
- CURRENTLY BEING HELD IN CONNECTION WITH THE KIDNAPPING, RECONTACTING INFORMANTS WHO HAVE BEEN HELPFUL IN THE CASE IN THE PAST, AND REIMPLEMENTING SURVEILLANCE OF SUSPECTS IN THE CASE WHO ARE STILL AT LARGE. IN THIS REGARD, VENEZUELAN SECURITY OFFICIALS ADMIT THAT THEIR INVESTIGATION OF THE CASE IN THE PAST YEAR AND A HALF HAS BEEN UNINSPIRED, SINCE MOST AUTHORITIES WERE CONVINCED THAT NIEHOUS WAS DEAD.
