SUMMARY: NEWLY APPOINTED MINISTER OF INTERIOR MANUEL JOSE MANTILLA CACERES IS SUPPORTING THE SPECIAL TEAM INVES-TIGATING THE KIDNAPPING OF UNITED STATES BUSINESSMAN WILLIAM MANTILLA HAS RELEASED THE GROUP'S OPERATING F. NIEHOUS. FUNDS, HAS AGREED TO ASSIGN MORE PEOPLE TO THE TEAM AND MAS ORDERED THE DIRECTORATE FOR THE SERVICES OF INTELLIGENCE AND PREVENTION (DISIP) TO COOPERATE WITH THE SPECIAL TEAM. AS FOR NIEHOUS, A SUSPECT IN THE CASE SAID IN LATE JULY 1978 THAT NIEHOUS IS STILL ALIVE BUT THAT THE OPERATION IS NOW IN THE HANDS OF AN INTERNATIONAL GROUP. MEANWHILE, THE VENE-ZUELAN ARMY IN BOLIVAR STATE IS INDEPENDENTLY INVESTIGATING THE REPORTS THAT NIEHOUS IS BEING HELD IN A REMOTE AREA OF THAT STATE. END SUMMARY.
