1. Reference is made to your memorandum of 12 September 1962, Subject as above, and to our memorandum of 26 February 1962 [redacted] on the same unknown subject. Our memorandum was predicated on information received from [redacted] concerning a KGB agent in New York City who, in 1951 or 1952, furnished the KGB reports prepared for internal use by an organization believed to be the National Association of Manufacturers (NAM). Your memorandum indicated that in 1952 - 1953 Nikolai Antonovich KOSSOV, a representative of TASS News Agency who was in the United States from 1945 to 1955, was furnished documents pertaining to the NAM by a controlled source of your New York Office.

It is possible that [redacted] was referring to the NAM as the "Association for American Industrialists." This office would appreciate being advised if the document [redacted] could be identical with any of the documents passed to KOSSOV in 1952 - 1953 by the controlled source handled by your New York Office.

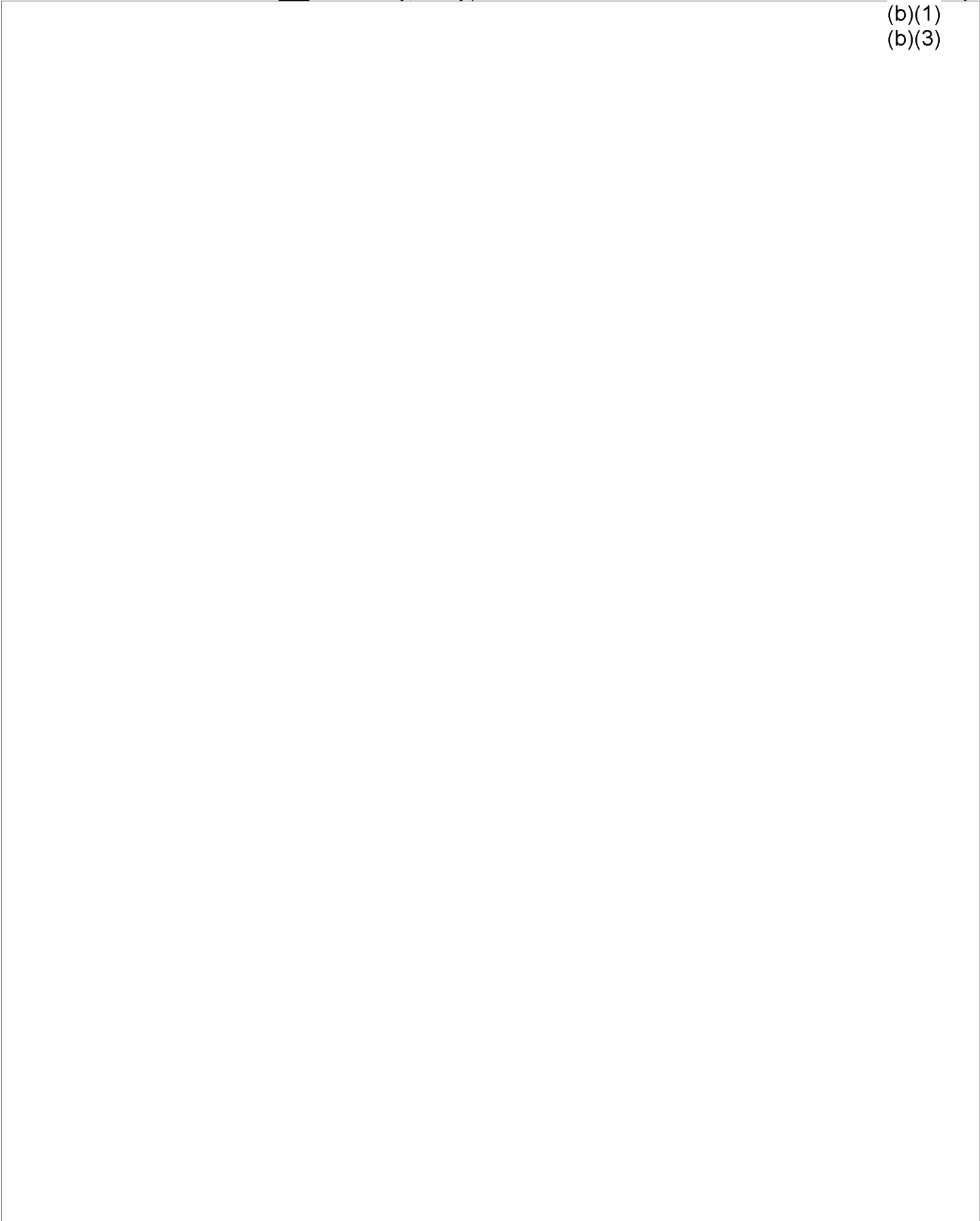
