Hi,

I received the following request from Jeffery Kaye for CIA Inspector General report regarding allegations of the use of mind altering drugs by the CIA to facilitate interrogation of detainees.

Under the Freedom of Information Act, 5 U.S.C. subsection 552, I am requesting information or records on a CIA Inspector General report regarding allegations of the use of mind-altering drugs by the CIA to facilitate interrogation of detainees.

This report was made most likely in 2009, the same time as the Department of Defense Office of Inspector General was concluding its own investigation into the same issue. In June 2012, DoD declassified a report on the results of their investigation, dated September 23, 2009.

I am enclosing a copy of the page of the DoD IG report that indicates the CIA conducted an Inspector General report on the drugging allegations described above.

The impetus for the investigation was an April 24, 2008 tasking letter from Senators Joe Biden, Chuck Hagel, and Carl Levin, which has been made public. I am also enclosing a copy of that letter.

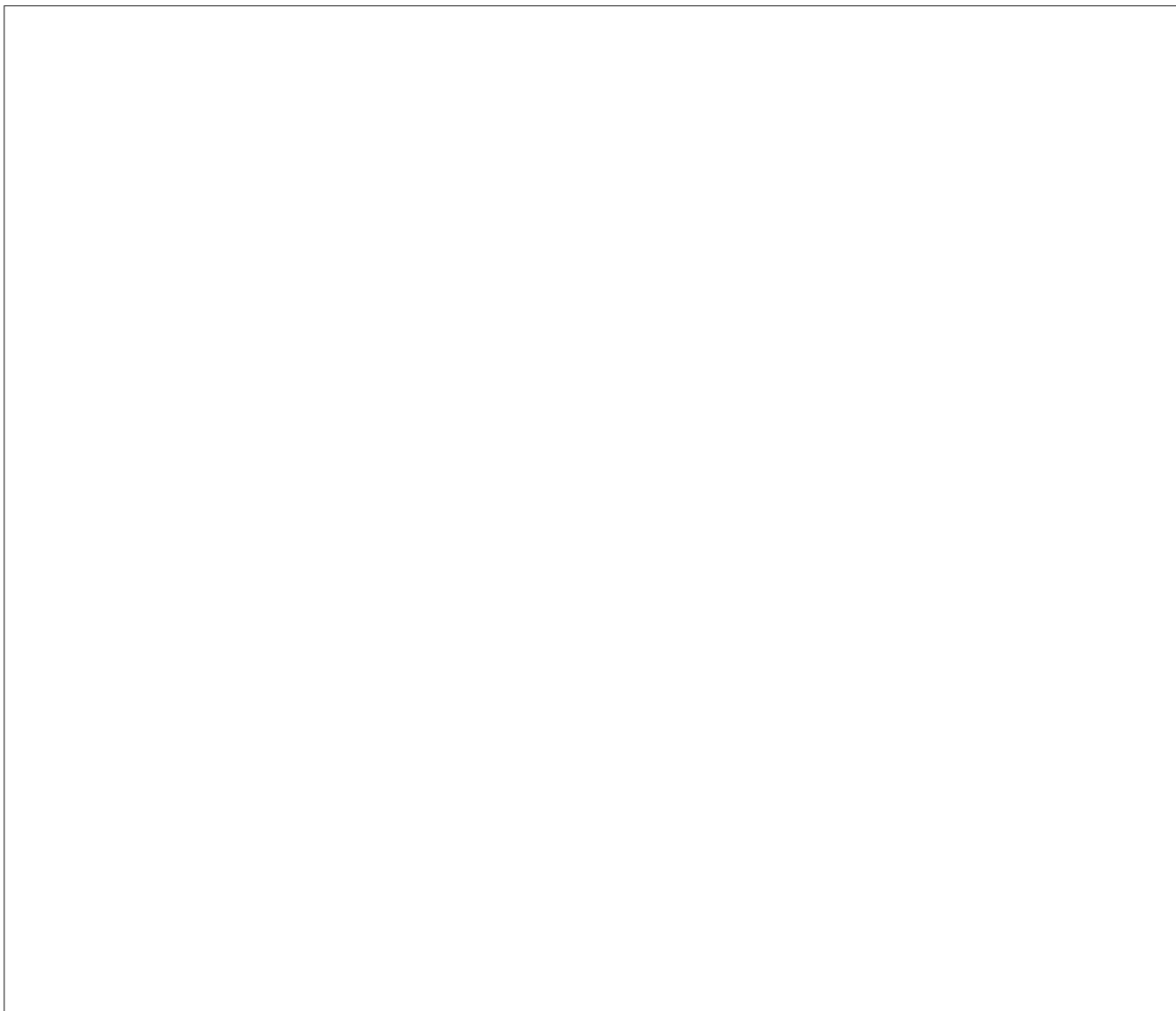
